President's & Sponsorship:

Presidents Report August 21

1. Following the resignation of Treasurer David Gunner on 28/07/21 I appointed Dick van Buuren to that position on a temporary basis until the next AGM. Dick is a retired Accountant, Group Secretary of Group 27 and showed a willingness to take up the position of Treasurer. He has been most helpful in checking the books over the last few months and is confident he can adapt to the Treasurer's role during the transfer of duties.

At the meeting I will be asking the members of the Executive Council to endorse my actions in appointing Dick to the position of Treasurer. I will also be asking Councillors to give Dick permission to proceed with any investigations he may consider

necessary to fulfil his duties e.g. Internet Banking, changing signatories on accounts etc.

I would like to publicly congratulate David and thank him for his many years of service to members of NSWVGA as the Tournament Director of Central Western (Orange) Week of Golf and Treasurer NSWVGA. He has been an excellent servant of our Association and I wish him well in his retirement.

- 2. I have been struggling to interpret the Motion, moved by Peter Guy and seconded by John Daley, allowing players to join NSWVGA from age 50 as of 1 January 2022. The statement, "this does not require groups or clubs to change their age limits for membership or tournaments," is confusing to Group Secretaries and members and I would like to see the adoption of this motion deferred until there has been wider discussion and a clearer solution to the impact it will have on all concerned.
- 3. In conjunction with the decision that all players be members of NSWVGA to play in NSWVGA events we should be clearer on the fee structure of those players who choose to pay fees to Tournament Directors and how that fee is processed through our system.
- 4. To date I have not done any costing for the Medal finals planned for later in the year. Covid has caused havoc with our program and I have already planned and cancelled two events and don't wish to invest time in another event which may also be cancelled.
- 5. Due to the cancellation of so many Weeks of Golf in recent months I am of the opinion that, as we did in 2020, we should offer compensation to those events which were affected by the pandemic. We should also consider what the recipient clubs should do with NSWVGA Vouchers, already forwarded to them prior to the cancellation of their events.

To all members of this Association, it is the Executive Council's hope that you stay safe and well in the coming months. Get the Jab, Wear a Mask and enjoy your golf.

Program Coordinator Report:

August Report Zoom Meeting Program

Overview

August sees us in the middle of a crisis that has effected this years and maybe next year's program.

2022 Program.

This will go ahead as scheduled. I have received correspondence from Tumut and Cootamundra who have indicated the intend to proceed with their weeks as scheduled.

I have heard nothing back from Gundagai and if nothing is forthcoming by the end of August I intend to ask Tumut to consider expanding their two days to a full week of golf.

Gundagai have had more than enough time to respond.

2023 Program

I have sent the draft copy to all councillors for comment. There are two scenarios for the events around Easter to try and overcome the problems associated with some weeks of golf. As this will be an agenda item for our ZOOM meeting the next step will be as directed by the meeting.

The Future

Over the last few weeks I have been contacted by Glen Innis veterans through their secretary who has had an extended stay in Yamba. They have indicated a wish to investigate a week of golf .They have received a basic outline of what is required to conduct a week but have been told that they must approach this through their Group

and then make application through NSWVGA.

There has also be unofficial approaches from Bingara to resume their week and for Wauchope to extend their two days to a week.

As I hear anything I will inform the Board on these matters.

NSWVGA Match Play.

We must now move to seek nominations for this event from 2023. Their needs to be a criteria established and nominations called. This needs to be an agenda item at this meeting.

Hears hoping things will improve as the year progresses or at least we can resume our weeks of golf in 2022. Keep well all.

Website report

NSWVGA – Website Report – Aug 21

1. Public website

- We recently had problems with editing the Groups & Clubs page which lasted over a number of weeks. These have now been resolved by MiClub rebuilding the page.
- The format of the 2022 Program has been modified to allow for the NSWVGA Rep to be identified for each event.
- Gerry Cox has agreed to join the team handling updates to the public site.

Action: Peter Guy to organize a login with MiClub and to provide training to Gerry.

• The Tournament Director and Group Secretary history pages have been created by MiClub as empty drafts. Dick Farrant has provided the historical data. We need to decide the best format to present these and then load the history.

2. New Membership Register

- We expect to get access to the initial version of the Register in the next week. The first step will be for Stu and myself to familiarise ourselves with it, check it out thoroughly, and discuss any amendments with Jo Hunter. I expect that this will take 2-3 weeks.
- When we are satisfied with the functionality of the site, the database has to be copied from the old site, cleaned up as far as possible, and loaded onto the new site. I expect that this will take 4-6 weeks.
- It is important to bring Group Secretaries into the process at an early stage because we need their help in getting the site ready. I suggest that they should each be contacted individually rather than through a general email, to cover the following
 - We need to advise them that the new Register will be brought into action in the next couple of months. They will get plenty of notice, and there will be a short period (less than a week) when updates will not be allowed.
 - They will require new logins for the new site and we need to check who currently uses a login for the current site and what for. Is it just the GS or are there other users? If there are other users, do they do queries only or do they make changes as well?
 - We need to check with each GS that the list of clubs for their group on the website is complete and correct.

• We would like to get an Excel file of their members so that we can check their records against our database as we load it. We will provide feedback to each GSs on any discrepancies we find. The file should contain at minimum the GolfLink number, first name and last name for each member but, to make it easy, we can accept any dump of their existing digital records.

Action: Who should be responsible for contacting the GSs?

 We need to identify <u>all</u> other users – TDs, Councillors, Richard Doyle – is there anyone else? We need to check how they use the current site – queries or updates?

Action: Who can take the lead in getting a definitive list? Note: we have a list of all the user ids from the current site, but it is known to be out of date.

3. Dropbox

I am in the process of setting up a set of folders on Dropbox so that we can all access the 'master' version of common documents and files.

The benefits of this are:

- The latest version is always easy to find in a standard place no searching through emails to find when it was sent out.
- Newcomers immediately have access to all documents that they require.
- No concerns about someone being left off an email list.
- It is possible to set documents up so that anyone can add comments or updates that everyone can track.

Note it will still be easy to download a copy of any document to your own computer if you want to access it or work on it off-line.

- Draft policies and minutes
- Internal procedure documents
- Excel version of the program for each year

- Email lists GSs, TDs, Exec Council
