# **Program Coordinator Report**:

August Program Report 2022

#### Overview

Once again wet weather has intervened and disrupted this year's program. Nambucca Heads could only complete two days of their week and Gloucester has now cancelled due to the ongoing bad

weather. Other events have completed although the various courses have been rain effected with somewhat diminished fields.

2022 Program

With any luck we should complete this year's program. Once again weather and Covid will be major factors and we will rely on Tournament Directors to provide ongoing information as to how their tournament will fair.

2023 Program.

There have been some requests to change some dates of some tournaments for this year, but I feel it is too late to make changes as dates have been set and accommodation booked by intending participants. These requests have been considered with the draft program for 2024 which will be covered later in this report.

This year is the last year for the Mixed Tournament held in Wagga. With the passing of Gary Mason there is a need for one of the councillors in the Riverina to step up and take charge of this event in its final year.

There is also some pressure to allocate stand alone weeks for Championship events during the year especially with the State Medals. Where possible this has been achieved but there will be some clashes.

2024 Program.

We are now in the fourth draft of this year.

It has become more evident that Tournament Directors don't want their event at Easter, school holidays or if public holidays fall during their allotted week.

New England and Northwest are a prime example, and it is not the Tournament Directors wish but rather that of their Golf Club. The weeks concerned include Easter and therefore the program reflects their program is the reverse of previous years with Easter taken out of the program.

The far North Coast is the same with both Nambucca Heads and Sawtell requesting their weeks be scheduled out of school holidays. With the demise of Coffs Harbour who have indicated they will not proceed in either 2023 or 2024 Maclean will now be the first week in July with Sawtell taking Coffs Harbour's week followed by Nambucca and then onto South West Rocks.

As there are now stand-alone weeks for Championships, especially the State Medal, this will effect the late end of the program that will effect Young and Kiama. Kiama especially have indicated they don't want their week extending into December, but this can't be helped.

A discussion on the State Medal, and their viability, may solve this problem.

A copy of this draft program is attached for all to view and comment on.

#### **Website Report:**

#### NSWVGA WEBSITE REPORT - AUG 22

#### 1. New Membership Register

Much progress has been made over the last 4 weeks, and we are nearly there.

I would be happy to give a demonstration after the meeting for anyone who is interested.

#### 2. Membership payment tracking

In the new Membership Register, we are keeping a record of every renewal, not just the current membership status. For each renewal we keep the following data:

- User who entered the renewal
- Date entered
- Year valid
- Date paid filled by user optional
- Affiliation Group filled by user optional

This means that we can easily generate lists of what monies should have been received from whom for what and when.

The affiliation group can be used to accurately generate the statistics for grassroots voucher allocations, or for any other use.

#### 3. Tournament entry

We have had a number of tournaments where the primary entry method is online, and in some cases the Tournament Director has not offered any alternative.

Where TDs are using the mitournament software, this only accepts entries if payment is made online using a VISA or Mastercard credit card. Note the mitournament software also requires the player to give date of birth and address.

I propose that we should require TDs to:

- a. allow entry using an emailed form and
- b. accept a bank transfer as payment.

Note that this is in no way a discouragement to using online entry - just that there should be an alternative for those who need it.

## 4. Email address lists

Up-to-date email lists for Group Secs, directly affiliated Club Secs, Tournament Directors and Councillors have been generated from the master details on the website. These are in CSV format which can be easily imported into any email program.

It is my intention to set up a Dropbox to contain these and other reference documents, so that Councillors always have the latest versions available for use.

- 2. Age reduction Golf NSW has advised that they have reduced the age for Senior Golf Events from 55 to 50 for both men and women, which included Soom Events. NSWVGA will watch and assess this moving forward.
- 3. Confirmation of room booking AGM Due to the non-response in writing from Bankstown Golf Club and the expense associated with Councillors attending Bankstown golf club. Clr Les Knox will liaise with them and other clubs closer to the airport. This may help to save on travel expenses.
- 4. Nomination form address change for secretary Secretary address for all or any correspondence to be sent to <a href="mailto:secretary@nswvga.com.au">secretary@nswvga.com.au</a>
- 5. Budget for 4Bbb Finals Due to the small number of completed Medal and 4Bbb nominations the finals at Nambucca and Forbes will be cancelled for this year. Clr James Shadlow will promote this event in his newsletter and the Committee will reassess this at the A.G.M.
- 6. Constitution changes- This is a work in progress and Clr Peter Guy will advise us when completed.
- 7. Life Membership The letter from Penny Hudson for life membership to be granted to President Ian Vidler was discussed and all councillors agreed. This can not be accepted at this meeting but will be put on the agenda for the 2022 A.G.M. and back dated to take effect from 10th August 2022. moved on motion Clr Peter Guy and Seconded Clr Dick van Buurencarried.
- 8. Grass roots Due to the lack of interest in this program from some of the bigger clubs and the ongoing expanses involved Clr Dick van Buuren will do a costing and report back to the Committee at the next meeting. Clr Peter Taylor stated that a lot of the clubs really appreciated the support given to them via the grassroots program, especially the smaller clubs.
- 9. Thurgoona be accepted into Group 25 Murray River, effective as of 1/10/22. Moved on motion Clr Stu Dossetor and Seconded Clr Dick van Buuren- carried
