President: President's Report for NSWVGA Executive Council Meeting 9th August, 2023.

The Executive Council of NSWVA are continuing with their review and update of:

- Constitution,
- New Members Register,
- Policies,
- Sponsorship of NSWVGA Championships and Weeks of Golf,

Perpetual Shields

Expressions of Interest have been called for:

AVGU National Championships to be held in NSW in 2027.

Proposed amendments to NSWVGA Constitution.

An extensive review of the NSWVGA Constitution was carried out by the Constitution Sub-Committee, Peter Guy, Dick Farrant and Lance Fredericks and submitted for consideration at a Special General Meeting of NSWVGA on 7th June, 2023. A motion to adopt the amended Constitution was defeated.

Since the June meeting further submissions have been received from Groups and Councillors. The Constitution Sub-Committee has taken those submissions into consideration and has revised the draft amended Constitution. This draft will shortly be circulated to all Councillors and Groups seeking further comments and input.

Generally, there is not a lot of disagreement on the proposed amendments to the Constitution, with the main sticking point being 'voting rights' at AGM'S and Special General Meetings.

It is proposed that all Groups and Councillors be invited to participate in a ZOOM Meeting in the second half of September to further discuss proposed amendments with the view of putting the amended Constitution for adoption at the December AGM.

Members of the current Executive Council have had extensive discussions on amendments to the Constitution, therefore it would be inappropriate not to try and resolve changes to the Constitution prior to the election of a new Executive Council in December.

New member's register.

Once again, I would like to acknowledge the incredible number of hours that Councillor Peter Guy has put into the creation and implementation of the New Members Register.

Access to the New Members Register for Group Secretaries and Tournament Directors has been proceeding but the time has come to make it a priority to ensure we only have the one Members Register. All Group Secretaries, Tournament Directors and Councillors must be in a position to use the same Members Register.

NSWVGA Policies

Thanks to Councillor Penny Hudson and her sub-committee for the work they have done on reviewing and updating NSWVGA Polices.

Their recommendations will be discussed at this meeting and updated policies will be placed on the NSWVGA Website once approved by the NSWVGA Executive Council.

The review includes Sponsorship of NSW Championships and Weeks of Golf.

The number of players entering Weeks of Golf and Championship events can vary greatly therefore a review of sponsorship is necessary to:

- Create a new policy setting out cost of NSWVGA sponsorship of all events.
- With some events, including Championship, having low entries, consider including a minimum number of entries be set for a tournament to proceed.
- Vary the level of sponsorship according to the number of players entered for a tournament.

Perpetual Shields.

Councillor Jim Shadlow has carried out a survey to establish if all tournaments have perpetual shields for both male and female players.

When the review has been completed a decision will be made on how best to ensure all events have perpetual shields for both men and lady players.

AVGU National Championships.

This event is programmed to be held in NSW in 2027.

The AVGU 2027 National Championships Sub-Committee has called for 'expressions of interest' to host the event.

An update of expressions of interest received to be advised at meeting.

Presentation of Certificate - Life Membership of Ian Vidler.

Penny Hudson, Councillor of NSWVGA, presented Lyn Vidler with a certificate of the late Ian Vidler's Life Membership of NSWVGA at the Nambucca Week of Golf in the presence of family and friends.

Penny said, "Last year before Ian passed away, he had been informed that he was to be awarded Life Membership of NSWVGA. A worthy recipient.

Today, Lyn, I would like to present you with the NSWVGA Life Membership Certificate".

NSWVGA Reciprocal Playing Rights with other States.

An inquiry has been received to see if NSWVGA has reciprocal playing rights with other State Veteran Golf Associations.

NSWVGA do not have reciprocal rights with other States.

To play in NSWVGA events you MUST be a member of NSWVGA, and that includes those who are members of other State Veteran Golf Associations.

All states are members of the Australian Veteran Golf Association (AVGU) and are eligible to play in the AVGU Championships which rotates from State to State each year.

Any NSWVGA member wishing to play in a veteran event in another State should check with the Tournament Director to see if they are eligible to play in that event as a member of NSWVGA or whether they are required to join the respective State VGA.

The first objective is to identify the parts that no-one has any problems with, so that we can then concentrate on the issues that require resolution. It is intended to hold a Zoom meeting towards the end of September to try and get a consensus on these outstanding issues with plenty of time before the AGM in December. All Groups will be invited to join this Zoom meeting."

Treasurer:

Treasurer's Report to NSWVGA's Executive Meeting 9th August 2023

- Lance Fredericks arranged additional cover with our Insurers to accommodate Sydney Vets request. Payment was made and I sent an invoice to Sydney Vets for \$207.90 but for some reason instead of paying us they paid it direct to the Insurer. This has now been refunded to us. Thanks to Lance for arranging this.
- John Dixon has now been added as signatory to our Bendigo account.
 - We now have five councillors signatory to both our bank accounts.

• I have previously highlighted that a number of Golf Clubs are now collecting the \$5 NSWVGA Membership as part of the entry form for their WOG.

Port Stephens is one of these clubs and collected \$150 for 30 signups for their upcoming WOG

Port Stephens submitted a list of these 30 for registration into our Members Register to our Representative but were told:

"Until Gary (TD) sends through the fees they will remain as un financial"

I disagreed with this statement and suggested to our Rep that these players be updated ASAP. This suggestion was not well received.

We need to know the correct procedure and we need a consistent approach!

Program Report Zoom Meeting 09/08/2023.

Introduction

This year is presenting some challenges that will be outlined below and they will need to be addressed at this meeting.

2023 Program

The Seaside and Valley week of golf nomination pack has not been placed on the website because they refused to change their eligibility conditions in their document. As it stands this is totally against Policy No 2. There needs to be discussion on this and a decision made as to our next step on this matter.

There is a problem with Brisbane Waters who cancelled this year and have now cancelled next year as well. I am of the opinion that this event will not run again mainly due to a suitable time during the year being not being available and also accommodation and the location of the accommodation. This has a big bearing on this event. There is extensive travel to get to golf courses no matter what part of the coast the week would be held.

The Trials at Barham seems devoid of any veteran involvement rather it is being handled by the Golf Events Manager and this is a worry to me especially when it is a veterans week of golf. We have Aileen on the ground and no doubt will keep an eye on this.

Harden is full steam ahead with TD Don Maling in constant touch with updates on the course and clubhouse renovations. They are slowly building up numbers for their event.

2024 Program

At this stage there are two changes

1 Glen Innes have moved from October to April to fill the gap left by Armidale withdrawing.

2 Sawtell have indicated they will proceed with their week of golf commitment in August. This is later than normal but their request along with Nambucca Heads for times outside of the school holidays period has been met.

The AVGU Championships will be held in Northern Territory at Darwin in August. This will have a minimal effect on our weeks of golf in this year.

2025 Program

The response from Tournament Directors has been better than past years. At this stage there has been no requests for any changes, but the Draft Program will still be sent out again at the end of this month for confirmation.

NSWVGA TECHNICAL REPORT – AUG 23

1. Membership Register implementation

There have been no difficulties reported with using the system itself. New users seem generally to be able to start using the system without any support.

Problems are regularly being uncovered in the data that has been brought across from the old Register. The most common problem is incorrect GolfLink numbers, and these can only be resolved by detailed analysis of each situation.

At the last meeting it was agreed that the transfer to the new Register should be speeded up, and in particular Group Secs should be asked to start using the new Register.

Of the 30 Groups, 20 have asked for and been given a login. Only 8 have made any updates.

Of the 11 Directly Affiliated Clubs, 6 have asked for and been given a login. Only 3 have made any updates.

During the last two months, there have been 201 updates directly in the new Register, and 302 updates have been brought over from the old Register. This shows that the majority of updates are still being done on the old Register.

Action: Get in touch individually with the inactive Groups and DACs to check where they are at and encourage them to start using the new Register.

2. Membership statistics

The following are the gross membership stats as at 2 Aug. As noted above, we are regularly finding errors or duplications in the data brought over from the old Register. As we progress through renewals, these problems will work their way out of the system.

Richard Farrant also stated that there is indecision regarding social clubs even at club level.

Clr Penny Hudson inquired about honorariums and that they were not discussed at the AGM last year as well as what were the amounts. Clr Dick van Buuren

stated that a check of all minutes on our web site will show that the subject of honorariums was never raised." Clr Les Knox commented that he could not remember honorariums ever being raised at any stage in his time on Council."

Clr Peter Guy replied that all suggestions regarding the honorariums would be covered in the discussion with the new constitution.

Stroke play championships

Clr John Dixon stated that due to the number of entries received this year it may affect the value of the trophies and number of trophies awarded at this year's tournament. Clr John Dixon will do a list of trophy numbers as well as their values.

President Les stated that while NSWVGA is gender neutral, we conduct events for both male and female as two separate events.

Clr Penny stated that she had received comments from players inquiring if we are gender neutral as to why can't some female players join at their local vets and why is NSWVGA not doing anything about the situation? Clr Peter Guy replied that NSWVGA does not become involved in local operations of groups or clubs. We only become involved in NSWVGA WOG and Championships. Some clubs are constituted to only allow male members to join.

Rand Wilson- Membership Issue

Players paying \$5.00 at WOG to join NSWVGA are able to play at local Veterans clubs. It is up to the local group as to what they charge those players and how they play. It is the aim of NSWVGA to have as many players playing golf as possible.

Seaside Flyer condition of entry

Richard Farrant stated he would liaise with Bob Smith to have him change flyer so that it conforms with NSWVGA policies. Players must be of 55 years old and a member of NSWVGA to be able to enter.

Clr Peter Guy will place the new document when received on the web site.

Clr John Dixon moved on a motion that NSWVGA purchase the number of shields required at a cost of\$80.00 each. seconded Clr Penny Hudson- carried

EOI to host the AVGU Nationals

Only two groups have replied to the initial email requesting interest to host the championships.

Those two groups that have nominated their interest to host the Championships will receive a final expression of interest document by middle of August. Those replies to reach NSWVGA Secretary by 1st of October.

Richard Farrant stated that he should refrain from any further involvement with the discussions on the final expression of interest when we receive them. President Les informed Richard that we really appreciate his input and expertise throughout this process. A discussion took place on Richard's involvement and it was decided that Richard would continue to have involvement with the final discussions as the final vote would be taken by the Executive Council. The same would also apply to Aileen except Aileen would have to refrain from the final vote. The proposed date for the Championships will be 8th to 12th November with rego on Sunday the 7th November. Clr John Daley agreed to put the proposed date into the program for 2027.

When the final expressions have been received the subcommittee will make a recommendation to the NSWVGA Executive Committee.

Peter Lawrence issues with the new members register.

 Newcastle Vets not in the new system as they do not own a golf club. Clr Peter Guy stated that this is a constitutional issue regarding bricks and mortar, and not an issue with the members register. All Newcastle vet members have been moved over and entered into the new system. 2. Group Secretaries are not able to do a search by group, only by golf club. It does not have a total by group which is needed to do yearend balance. Clr Peter Guy stated that this is correct. But at the moment we are focusing on giving access to all group secretaries and tournament directors and making sure that they can use it.

There may be enhancements required in the future.
