President's Report for NSWVGA Executive Council Meeting 11 October, 2023.

Closure of NSWVGA Member's Register.

The old NSWVGA Member's Register was closed on 30th September 2023 with all membership information now available on the New NSWVGA Member's Register.

I would like to take this opportunity of thanking Barry Maloney, who developed Old Member's Register in 2016 when NSWVGA decided to change management of the Member's Register. Since that time Barry has maintained the website until its recent closure.

During the past 8 years Barry has done everything asked of him and our Association is extremely grateful for his assistance and guidance during that time.

Relaying of information to Group Secretaries and Directly Affiliated Clubs.

During the last 12 months the Executive Council has worked on updating many matters including the following:

- Constitution,
- New Members Register,
- Policies.

The Executive Council have tried to keep all Group Secretaries, Directly Affiliated Clubs and Members updated with the changes being made and recommended, through News Letters, Emails, Meeting Minutes and telephone calls.

It is difficult to ensure that all Clubs and Members receive information circulated as on occasions information relayed gets lost or overlooked during transmission stages.

For changes to be effective all Groups, Clubs and Members must be aware of changes and amendments adopted. Are there other ways we can improve our methods of communications to all parties involved?

The Association might look at allocating Groups/Clubs amongst Councillors who could contact the Groups/Clubs allocated to them by telephone and or email, to ensure all get and understand changes or amendments made or recommended.

The Association should also take steps to remind Groups/Clubs when it is time for them to renew membership as I am aware that some renewals of memberships have been overlooked.

Proposed amendments to NSWVGA Constitution.

An extensive review of the NSWVGA Constitution was carried out by the Constitution Sub-Committee, Peter Guy, Dick Farrant and Lance Fredericks and submitted for consideration at a Special General Meeting of NSWVGA on 7th June, 2023 when a motion to adopt the amended Constitution was defeated.

The Constitution Sub-Committee has called for and received further submissions.

A lot of time has been spent on debating proposed amendments to the Constitution and the time has arrived when decisions have to be made and accepted, as we are working with a constitution that is outdated and, in my view, unworkable in its current format.

Conclusion.

As previously indicated it is with deep regret that I will not be seeking election for any position on the Executive at the next AGM in December, 2023.

I have thoroughly enjoyed my years on the Executive Council and have been so lucky to have met and worked with many veteran golfers who I am now honoured to call friends.

I would like to take this opportunity of thanking Tournament Directors, Group Secretaries and Members of the Association who voluntarily give up so much of their time to make this Association the success it is today.

There are times when Tournament Directors receive adverse criticism on the way their tournaments are conducted. Remember these Tournament Directors prepare for tournaments over the preceding months and go through many stressful hours doing their very best to conduct golf tournaments for the benefits of the NSWVGA and its members. It is important not to be critical of these dedicated people, but work with them through constructive discussions to see how each tournament can be improved.

Program Co Ordinator Report:

Program Report Zoom Meeting October 23

Introduction

We are well into the back half of the year, having completed 45 of the 57 events scheduled for the year. There were three events cancelled but at least two of these, Sawtell and Howlong, will go ahead next year. One of the events completed was the trial at Barham with the trial at Harden to proceed in November.

2023 Program

As mentioned, we are well into this year's program, and it must be pointed out that in some instances numbers are on the increase but sadly there are some events that are starting to struggle with numbers which may be due to the economic climate but not entirely to this fact. There seems to be a decrease in the promotion of some weeks of golf by weeks of golf committees who are relying on either past performances or expecting NSWVGA to promote their event. There is also a growing trend for the Golf Club administrators to run the event with little or no help from veteran groups. This will see the demise of their week of golf unless Veterans are prepared to get involved and either run the event or participate in its running.

2024 Program

At this stage there are two changes

- 1 Glen Innes have moved from October to April to fill the gap left by Armidale withdrawing.
- 2 Sawtell have indicated they will proceed with their week of golf commitment in August. This is later than normal but their request along with Nambucca Heads for times outside of the school holidays period has been met.

There has been a request from Wauchope to extend their two-day event to a four-day event. They have been told they will have to request this firstly through their Group and then make a formal request to NSWVGA to be considered. As far as the program is concerned there is a spot prior to Manning Valley, (Taree , Tallwoods and Harington Waters) from $7^{th}-11$ October. I have contact Port Macquarie as a courtesy to see if they wish to extend their two days to four days, but they cannot because of their commitments to their club program . This may open the door for Emerald Downs to be approached to see if they want to fill the gap left by Wauchope. Either Charlie or I will keep all up to date on this matter.

The AVGU Championships will now be held in South Australia along the Riverlands which includes Loxton, Barmera, and Berri. This event will clash with our event at Leeton which the AVGU would be quite oblivious and as such we as the Board should be encouraging NSW vets to support our own as this was a last-minute change and something that won't allow us to reschedule our program to support both events.

2025 Program

We are now at draft no 4 stage. All of the changes have been for the change of Tournament Directors and their contact details. The draft no 5 will be sent out in early November with a cut-off date of 30 th November for any last-minute changes and this will then be presented to the Board for approval and be placed on the website in January 2024.

1.1.1.1.1 Membership Register implementation

Of the 30 groups, all have applied for a login except:

About half of the DACs have done updates.

Rob Trembath is chasing up the inactive groups and clubs.

There have been no difficulties reported with using the system itself. New users seem generally to be able to start using the system without any support.

2 minor errors have been found – these have been notified to the developer for correcting.

Problems are regularly being uncovered in the data that has been brought across from the old Register. The most common problem is incorrect GolfLink numbers, and these can only be resolved by detailed analysis of each case.

1.1.1.1.2. Membership reconciliation

Some Group Secs have expressed concerns over the reconciliation capabilities of the new system.

On a monthly basis I produce an analysis of updates made by users and share this with Rob and Dick. The September analysis is attached.

Also attached is an analysis of memberships by Group and Club. Because of the erroneous data that we are still correcting, these numbers are suspect. When we have been through a full cycle of renewals on the new register, the numbers will be much more reliable.

We will work to develop procedures to assist Group and Club Secs to reconcile their records.

1.1.1.1.3. Public website

The public website is now running smoothly, although there are still members unaware of it or looking at other sites. We must continue to get the message out that the official website is the place to go for event info, results and news.

The first documents for a 2024 tournament were received in August, and others are now coming in. I recommend that each Tournament Director is contacted to check on their documents in advance of their submission to head off any potential re-work.

Gerry has asked us to remind everyone that any items for the News or Results sections should be submitted as editable text (e.g. Word document) and **not** as a pdf. Please could all Councillors help to get the message out.

Letter from player that played at the week of golf held at Yamba this year.

Secretary to reply to member that the TD for Yamba Week of golf did follow Policy two, but we are aware that there were some miscommunication issues.

As the only expression received to host the AVGU Nationals in 2027 was received from Group 3 Illawarra Secretary Steve Wicks it was decided to award them and inform group 3 that their submission to host the championships was successful.

Clr John Daley was concerned about sponsorship for the event. Richard Farrant answered that the group was waiting on approval of the submission and now that they have achieved approval they will cement the different levels of sponsorship. As there are different levels of sponsorship available it, which will be obtained and spread out over the 4 years of the sponsorship. The clubs involved will be asked to book their courses now and not in 4 years time.

Dick Farrant was asked if the Illawarra Vets to supply a press release for the NSWVGA website.

The committee thanked Richard for all his work in preparing the documents for EOI to host the AVGU Nationals 2024 Championship that went out to all group secretaries.

AVGU Nationals 2024

As Secretary Aileen is to attend the AVGU AGM in November, Secretary Aileen to make it perfectly clear as NSW have the highest percentage members base and as such NSWVGA will not be increasing their fees payable to the AVGU.

The change to the location and the date for the 2024 Nationals which will be held in South Australia in October it will now have an impact on NSWVGA Calendar ie the weeks of golf programmed for October so the clubs that will be effected are Leeton, Howlong, Deniliquin as well as Griffith. This will make it very difficult for NSWVGA to promote the National Championships.

A discussion took place on the amount of the honorarium that is paid to the secretary and president of the AVGU. Richard Farrant explained that he received from the AVGU \$1,500 which he then used to attend the Nationals and did not ask NSW to pay any expenses for him to attend and represent NSW

Anthony has replied that they are very interested and will forward further details in the coming weeks to NSWVGA via Clr John Dixon.

Members register: Robert Trembath

Clr Robert Trembath has tried to contact all group secretaries. Some have not returned his calls.

We have quite a diverse range of people trying to access the members register.

Some group secretaries are using the new members register without any issues and are doing a really great job. Some are finding the register no longer accommodates all of what they were able to do previously.

Some group secretaries stated that have not used the new register and do not have a login as they do not do things on their computer.

A discussion took place on when and how the members register should be updated and the money collected.

The process that is currently being used one does not always match the other.

Clr John Daley suggested that at a week of golf then the rep for NSWVGA collects the \$5.00 fee to join NSWVGA and the Group secretaries collects the membership at club level.

4BBB Championships:

To improve numbers at the 4BBB Championships does it have to be a stroke event?

Clr John Dixon suggested to increase player numbers attending the 4BBB event. That we change the 4BBB Championships to a 4 day event.

Clr Peter Taylor confirmed when the event was held at Glen Innes it was held over 4 days. The Championship was played as a stroke event.

A two-day Stroke event and a two-day Stable ford event was recommended. Clr Jim Shadlow is to contact Tura Beach and let them know of the recommendation.

No motion was proposed or seconded.

Guyra Vets proposal for 3 day Tournament-

The trial was approved. Guyra Vets are working on a flyer for the week of golf and will send out a flyer to Clr Peter Taylor for consideration. Peter will then send it onto Clr John Daley for approval and placing onto the calendar for 2024

Clr Peter Taylor has been approached by players to extend Wauchope WOG. Clr Peter then consulted with Wauchope Vets Committee to extend their week of golf to which they agreed. A tentative date has been set for 2024 to proceed Manning Valley.
