REPORTS:

Presidents Report August NSWVGA

Firstly, to Jim and Di Shadlow on the loss of their grandson, may I pass on from NSWVGA our deepest sympathy. Thank you to Aileen who sent flowers on behalf of NSWVGA.

Since our last Board meetings things have been a bit quiet.

I have had the chance to visit and play weeks of golf and catch up with veterans over the last two months and it is good to see many familiar faces and meet new members playing vets golf for the first time.

Both Moree and Narrabri had disappointing numbers and I don't think it has anything to do with a change in the schedule. When you see how successful events such as Inverell and Glen Innis were and the numbers that attended there, but they have to be enticed to the events by advertising, attending other weeks and in general promoting the event. It won't just happen. Our role in this is communicating with the Tournament Director and assisting him/her in any way possible but it is not our job to run the event.

Maclean and Ballina ran very successful weeks with both having new Tournament Directors who are to be congratulated on their outstanding achievements.

On another front, Registrations at weeks of golf need to be streamlined. No two councillors operate the same way, and this has led to embarrassing moments when checking memberships.

I have spoken to councillors who have attended registrations this year to ascertain the roadblocks in the system. They are many and varied. With the help of these councillors a new process has been developed that will be discussed as an agenda item at the Zoom meeting on 14th August.

Since the last Board meeting Councillor Jim Shadlow has been working on a new Affiliation Structure for our weeks of golf. This has been sent to all along with some changes and modifications submitted from Councillor Rob Trembath. This is also an agenda item at the next Zoom meeting.

Policy No7 has caused some angst. Councill Peter Guy has submitted a detailed summary of how he interprets the policy but the policy in no way reflects what we are trying to achieve here or what Peter has outlined.

It is a given that no two groups operate the same way when paying affiliation fees because of their financial year. It is my view we should not try to change this but work in with the Groups with this proviso:

All groups know the financial year of the clubs within their Group. Whether it be February, June, July September or October. The group Secretary sends an invoice to that club at the appropriate time with his list of current members asking the secretary to update this list and send him the affiliation fees for his club. He gives the secretary a month to comply after which time his club members will be deemed to be unfinancial. Some may feel this is a bit harsh, but it works.

The Group Secretary then updates the members register and forwards the affiliation fees to the NSWVGA Treasurer. This means that the Group Secretary updates as he gets the Clubs affiliation fee. This is a continuous process

This is what Policy No 7 should reflect and not extended affiliations after certain dates.

The information being gathered for councillor Charlie Swyer is going well. All representing NSWVGA at Weeks of Golf are collecting the relevant information and forwarding it on.

On a more disturbing note, I have noticed that some Tournament Directors are not following Policy No2 and in particular the distribution of trophies. This specific area has been outlined in bold letters for a reason in the policy and that is to ensure a greater

distribution of trophies amongst the attending players.

The Councillor attending the week should ensure the Tournament Director is aware of the policy and that he intends to follow it. The Sunday registration would be a good time or even earlier when obtaining a list of players.

Councillor Peter Taylor is still looking for councillors to attend some weeks of golf. They are in the mid North Coast area. Will you please contact Peter to help out.

On the AVGU front, the AVGU has sent an Agreement Document for signing. When you read the Agreement, point 10 outlines who can play in the AVGU Championship which includes partners under 55.

South Australia have indicated to AVGU that they are not happy with this and have moved to have this changed to show that all players must be a member of a veterans group. It has been pointed out that this was included in the early days of the event to bolster numbers.

This point must be removed from the Agreement to reflect current times. With this in mind, with the agreement of the NSWVGA our representative at the AVGU AGM will move such a motion.

<u>Treasurer's Report to Executive Council - Meeting 14 August 2024</u>

Update on matters for follow up June EC Zoom - File sharing. In conjunction with Peter Guy and Catherine Pautsch offerings for the sharing and archiving of files have been investigated. Zoom meeting held 10 August with Peter Guy and Catherine Pautsch. Peter spoke of the need to differentiate between file sharing and file archiving as well as the need to establish protocols for each of these functions. Peter also spoke to the need to ensure that there were sufficient people offering backup for active documents and the access rights to be appropriate to ensure uninterrupted operations of the NSWVGA. Peter also stated that naming conventions should be established to ensure a consistent approach to the file hierarchy to help future users identify appropriate file path and locations. Catherine provided overview of her observations of Microsoft 365 on the Family package as used by a friend in the small business operation. Catherine spoke to Storage Capacity and File Sharing capabilities. As a Microsoft 365 user I shared a link to a file during the Zoom meeting to confirm file sharing capabilities of Microsoft 365. During the meeting it was agreed that, after confirming with President we would acquire up to two Family Packages at a cost of \$139 p.a. each which offered sufficient storage and functionality to meet NSWVGA needs. Earlier in the meeting Peter Guy had suggested we also investigate not for profit offerings by Microsoft. Following the meeting I contacted Microsoft sales team and was referred to appropriate web page outlining offers to not for profits. In testing eligibility for what may be a free package, I have since undertaken a Self-Assessment on behalf of the NSWVGA as to the Tax-Exempt Status for ATO purposes as this is one of several criteria for the Microsoft offering. I will table the self-assessment separately in the upcoming EC meeting of 10 August. Note that this also requires lodgements with the ATO which I will try to confirm in coming days, prior to the EC meeting. From 1 July 2023, noncharitable NFPs with an active Australian business number (ABN) self-assessing as income tax exempt need to lodge an annual NFP self-review return. There has been difficulty in updating NSWVGA ABN details, despite efforts by Aileen to date. John Daley, Aileen, and I are working

through requirements to ensure our obligations with the ATO in this regard are met. I have also initiated application for Grants Program (free access to Microsoft 365 Basic package which is sufficient for NSWVGA needs). I expect to hear back on this in the next 10 business days.

Grass Roots Program

As at 11/8/2024 a total of \$5,175 has been paid with the last claim being paid on 30 June. This is just \$1,650 up from last reported figure of \$3,550 at the last EC.

Councillors will recall the total Grass Roots payout was expected to be \$7,750 across the 30 Groups and 12 Affiliated clubs with paid up members. I do not propose to follow up with respective Group Secretaries but would recommend a final reminder be included in next Group Secretaries Newsletter to the effect that closing date for applications be made by 30 September in line with NSWVGA Financial Year.

As previously advised the tracking individual club level payments and Members register details is a huge challenge which would need to be addressed if future Grass Roots payments are to be similarly structured.

In several cases the Grass Roots funding have been applied at a nominated Veterans competition with recognition of sponsorship by NSWVGA, this has been by no means a consistent approach with follow up several groups required as to application of funds.

Week of Golf Payments

Emails sent to Tournament Directors up to Broken Hill Week of Golf in late September to early October. One exception has been the Dubbo event with John Dixon, as he and I have been involved in several discussions and agreement of funding subject to final numbers.

Finance Committee

There was no finance committee meeting held since last EC meeting due to limited activity in terms of Weeks of Golf or other finance matters other than business as usual in collecting affiliation fees, reimbursing councillor expenses and payment of Week of Golf sponsorships.

Members Register Committee

Members Register committee meetings to re-commence in September with the benefit of a full rolling twelve months of financial and MR activity data. It is hoped this will provide a better view of any discrepancies across groups.

Financials to end July

Financials in the customary format follow, happy to address any questions arising.

Current YTD compared to Previous YTD reveals total Affiliation Fee income is down approximately \$4K on previous ytd. Total expenses are up by \$7.3K with Grass Roots payments and increased

WOG Travel Subsidies offset by timing differences in Championship Sponsorship Payments and Week of Golf Sponsorships.

Of course, the combination of decreased income and increase expenditure results in a Year-on-Year reduction in Total Cash at Bank. Nonetheless the Association remains in a sound financial position with ample liquidity to meet all foreseeable financial obligations as and when due.



Membership Register take up

New users seem generally to be able to start using the system without any support, and there have been several new users who have done Bulk transactions.

There have still not been any transactions from Cumberland, which is currently shown as a Directly Affiliated Club.

I suggest that someone should try and contact them to see if it should still be a DAC. If it is not active as a DAC, we should change its status and update our website.

The most common data problem being experienced is incorrect GolfLink numbers brought over from the old register – these are progressively being resolved as they are identified.

When a user finds a GL number that needs to be changed for any reason or deleted, they should send all the relevant details to webmaster@nswvga.com.au

The Q&A document is still in preparation. It will cover the areas that are giving rise to questions (membership validity, affiliation groups, changing GL numbers). When I've finished it, we can distribute it to all users and subsequently make it available for download from the Register website.

Membership Register development

There has been no progress in developing the new functions since my last report – I am still in discussions on what is the best way to proceed, taking account both costs and providing a good basis for future changes.

As an interim measure, I have developed a spreadsheet which will allow us to extract lists by Affiliation Group when requested by Group Secretaries.

Membership Register administration

The administration of the Membership Register will be shared amongst Rob Trembath, Gary King, Steve Mitchell and myself. I am working on getting things set up to allow this to operate efficiently.

Public website

Gerry Cox is continuing to handle News and Results items.

Catherine is handling most of the updating of the public website.

No progress on putting up a larger NSWVGA logo on the Home page. The version we are currently using is not good enough quality for enlarging.

Does anyone have a higher resolution version of it? Or does anyone know a friendly graphic artist who could enhance it?

We should perhaps change the structure of the Home page to make it (somewhat) easier for us to do what we want without having to ask MiClub each time.

File sharing

File sharing has two objectives:

to allow multiple people to work on a single central copy of certain files;

to ensure that all NSWVGA files are securely archived and available for whoever needs them without dependence on individuals and specific devices.

Following discussions, it is proposed to use Microsoft OneDrive for file sharing and for maintaining central copies of all NSWVGA documents.

There will be one sharing group for files associated with the public website, including:

Program spreadsheets
Event documents
Program tracking spreadsheet
Group and Club contact details
Minutes
Constitution
Policies
Text for all pages
Change tracking spreadsheet
Maintenance instructions

There will be a second sharing group for files associated with the Membership Register, accounts and other technical matters.

Catherine and Gary are respectively setting up these two groups on a trial basis. The expected cost is approximately \$280 p.a.

We will develop procedures for using these sharing groups.

NOTES ON AFFILIATION GROUPS AND PAYMENTS AUG 24

- There is no group 99 it is just a code for members who are not affiliated through either one of the NSWVGA geographical groups or through a Directly Affiliated Club. There is no common connection between these members. They do not know each other and there is no way that they could "organise their own group".
- We have to recognise that there are a variety of reasons why someone does not join through their home group. We cannot simply say that we want them to go away. We should not bring in 'special case' rules for one situation when there are many other comparable situations.
- We do not need a new field in the register the Affiliation Group is designed to record where a membership has been registered. An analysis of the 'Veteran Club' field in the old register showed that it was not being used other than as the equivalent of Affiliation Group:
 - of the 15033 NSW members, 13298 had the identical Veteran Club to their Home Club (over 88%).
 - of the 1735 NSW members where there was a difference between the Veteran Club and the Home Club, 1193 had a single Veteran Club for everyone in the group and 213 were in a group where there were just two standard Veteran Clubs for everyone in the group.
 - there remained 329 NSW members (about 2%) where there was a difference between a standard group id and the recorded Veteran Club. From observation, it appears that the majority of these were simply 'migrants' joining a vets group away from their Home Club.
- The main obstacle is that I have not yet managed to get a List by Affiliation Group function implemented in the Register. I have developed a separate extract spreadsheet which I have shared with the Membership register committee to generate lists as and when requested by GSs.
- Currently there are a lot of members who may have been registered with an incorrect code, either because they were brought over from the old register or because the user registering them was not clear on what to do. These will progressively fall off the radar once simple guidelines have been well publicised and implemented by all users.
- Whatever guidelines we put in place must be clear, simple and must be fair for all. The current \$5 payment at a WoG has been shown to be just that. Any increase should be also be at a flat rate.
- If we want to increase the 'unaffiliated' fee in order to give funds for the entity that registers them, that is fine. However, we should apply this to everyone who is unaffiliated (for whatever reason) and it should be at the same rate for everyone. Unaffiliated NSW members should not pay a different rate from interstate members.
- There should be no difference in cost depending on where an unaffiliated member signs up. It would be very confusing for everyone if players had to pay a different rate from week to week.
- Any change to the rules must be well thought out and justified and there must be plenty of publicity and plenty of notice. For example, if we want to increase the unaffiliated fee there should be a full 12 month notice so that word can get out to organisers and participants of all events. Preferably any change should be applied at the start of a calendar year.

Ultimately, we should reflect our stated objective: "Promoting and supporting fun and fellowship for veteran golfers and their Clubs in NSW". We should be supporting our weeks of golf by encouraging participation and not putting any complications in anyone's way.

The due date for membership payments is dependent on each club – NSWVGA cannot direct clubs (or individuals) on any particular calendar date. In this regard, NSWVGA can only direct the timing of transferring funds to the NSWVGA Treasurer.

NSWVGA does not control the allocation of GolfLink numbers. NSWVGA cannot decree that a GolfLink number will be forfeited. The only thing that NSWVGA can control is the validity of membership of NSWVGA, and the only thing that this affects is the rights to play in NSWVGA events.

It is not clear to me why Group Secretaries would send an invoice to clubs based on historic data. Surely, the first step is that clubs ask their members for fees and then inform the GS of who has paid their fees
