Treasurer's Report NSWVGA Executive Council Meeting 4 December 2024

Update on matters arising Executive Council meeting 16 October 2024 -

<u>Microsoft 365:</u> - Following confirmation from Microsoft that NSWVGA does not qualify from its grants program which offers free access to a suite of programs, one family group has been set up in place of my personal Microsoft 365 account. At this stage, the cost/benefit of the Family Group is still being investigated. To this end Councilors Trembath, Dixon and Pautsch have been invited into this family group. If suitability confirmed I will seek reimbursement and a second family group will be set up with relative Councilor also to be reimbursed for establishment, The Family accounts will then remain the property of the NSWVGA with Councilors having to arrange replacement Administration prior to relinquishing Councilor role. Catherine Pautsch has volunteered to explore the cost/benefit and will report back at a later stage to the Executive Council.

<u>Finance Committee: -</u> The finance committee held Zoom meeting on 7 November to review Week of Golf Prize Money and Championship sponsorship levels. The meeting canvassed a broad range of options, thank you to those councilors offering their thoughts. After a prolonged discussion about the various methods currently applied by Tournament Directors (T/D's) in relation to the promotion, or otherwise of the NSWVGA Shield, the following was agreed as the Finance Committee recommendation for consideration by the EC.

The number of Tiers for Week of Golf Sponsorship be reduced from 4 to 3 as outlined below. It was also agreed that to maximise the impact of NSWVGA sponsorship the spread of prizemoney given by the NSWVGA be reduced to First and Runner Up only. The Committee, however, felt it was appropriate to allow T/Ds to add third place prizemoney from Sponsorship and or nomination fee funds if they wish (I am aware that some T/D's currently supplement NSWVGA prizemoney with additional funds). This would be voluntary and entirely at T/D's discretion. The allocation of the NSWVGA Sponsorship should be as follows: -

<u>Update of ABN Registration Details and completion of Not-for-Profit Annual Self-Assessment Return: -</u> I have followed up in a series of phone calls with the ATO to ensure ABN update form was received and acted upon. Now that this has been completed, relevant information for lodgment of Self-Assessment return is now being mailed to me. Once to hand I will lodge return, and we will be compliant with the new legislative requirement.

Treasurers Comments Financials Year to Date - 30 November 2024: - As can be seen from the following report we remain in a sound financial position with total funds at call of \$68,284.20 plus Term Deposit of \$21,634.99. Whilst still early in the new Financial Year some matters of note are that Expenses are down \$2,893.92 compared for the same period last year. This is largely due to the non-recurring expense of the purchase of the Laptop computer; Travel expenses to meetings are also down by \$3,050,40 this is largely a timing difference with all councilors expected to claim travel expenses in coming weeks; Week of Golf Travel Subsidies are up by \$2,000 on previous year reflecting \$100 per week of golf increase (this item is now due for review by Councilors I intend to raise this in general business later in this meeting); Expenditure on Trophies, Shields and Presentation Folders is up by \$1,014.38 this is the result of the receipt of another batch of 40 NSWVGA Medals to be awarded in the future; Week of Golf Voucher payments are up by \$430 on previous year this is reflective of the current(previous) change of sponsorship levels based on 4 tiers according to number of players; Website expenses are down \$1,394.20 on the previous year due to non-recurring expense relating to Club Search function in the Members Register. On the Income side, Income Year on Year is down by \$9,553.66 this is due to a reduction in Affiliation fees of \$8,748 compared to the same period for the previous year. The reduction is likely to be a timing difference for some groups in the remittance of Affiliation fees, the most notable of these are Gr 2 of \$6,535, \$1,260 for Gr 27, \$1,200 for Gr 29. I will check this over the coming month and, if necessary, contact relevant Group Secretaries; Sponsorship is also down \$800 on previous year, I am not aware of status of Sponsors intentions for continued sponsorship.

We have not yet been able to set up automatic re-direction for emails to Group Secretaries, Club Secretaries and Tournament Directors.

Catherine is maintaining a master list of email addresses and anyone who wants to send emails to these categories should get the up-to-date list from Catherine each time. Please do not use privately maintained lists.

File sharing

File sharing has two objectives:

- to allow multiple people to work on a single central copy of certain files.
- to ensure that all NSWVGA files are securely archived and available for whoever needs them without dependence on individuals and specific devices.

Gary King has purchased a Microsoft 365 Family pack. We now believe that only one package is needed to cater for all of our needs.

Catherine and Gary will test out the product in the coming weeks.

We are developing procedures for using the file and folder structures.

Membership Register

New users seem generally to be able to start using the system without any support, and there have been several new users who have done Bulk transactions.

There have been quite a number of cases where the Affiliation Group was not set correctly for renewals. This was easily overlooked because the system offered a default to the Affiliation Group from the previous year. The system has been changed to have no default, so the user now has to explicitly set the value. This means an extra couple of keystrokes for users, but hopefully will minimise the number of incorrect settings.

When a user finds a GL number that needs to be changed for any reason or deleted, they must send the full details to membreg@nswvga.com.au. Please do not just add the member again with the new number – this results in duplicate records which then need correcting.

The Q&A document is still in preparation. It will cover the areas that are giving rise to questions (membership validity, affiliation groups, changing GL numbers). When it is completed, we will distribute it to all users and make it available for download from the Register website.

We are still in discussions on what is the best way to proceed with development of additional functions, taking account both costs and providing a good basis for future changes. Additional functions are required to make it easier for administrators to correct errors.

We have a spreadsheet to produce lists by Affiliation Group or by Club when requested by Group Secretaries.

Public website

Gerry Cox is continuing to handle News and Results items.

Catherine is handling most of the updating of the public website.

The 2026 program is being prepared and will be uploaded early in the New Year.

Matters arising from Technical Report

Catherine Pautsch has sent a test email and requested a response from each councilor to ensure the email reaches all intended recipients. If working as intended

It was explained that such a group email address for the Group Secretaries would create an additional workload to maintain the mailing list. Rather, it was determined that a current list of Group Secretary emails would be maintained by Catherine Pautsch and should be used whenever outbound email to Group Secretaries was required.

Councilors were reminded that when sending email to bulk recipients to include intended recipients in "BCC" rather than "To" label. This would assist in working around spam filters by various email client servers and also prevent bulk replies to all recipients.

Q and A sheet for Members Register is now complete and will be circulated to Rob Trembath and Gary King for review in the coming days.

In addressing concerns from some Group Secretaries about additional functionality, we are currently exploring alternative contractors to maintain the Members Register. This is the result of quotes from existing developer, which appear excessive for any future amendments to the Register. A suggestion was made that John Swan from Grafton may also be worth contacting in this regard.

A change has also been made to recording the affiliation group process which may require a couple of additional keystrokes group secretaries when renewing membership. Previously information incorrectly entered would be carried forward. Now when the group secretary does a renewal then the affiliation group needs to be entered each year.

Given a large number of Errors entered by some users, it was determined that we should give some thought to limiting the number of users that are able to access a financial update. All users would still be able to correct spelling or gender errors, do a general or even a bulk inquiry.

A list of names relating to a deposit could be sent to the treasurer along with the funds. This list could then be forwarded on for updating the members register. This may be proposed as a service that we provide to group secretaries in assisting them to maintain membership records.

In future, when a councillor does a bulk inquiry could they please send him a copy. This will allow Guy to build up stats on who is attending the weeks of golf. This would further assist in determining value for members affiliation fees.

Accepted on motion of Peter Guy to adopt the technical report Seconded Jim Shadlow- carried.

Program Coordinator:

Over the last year we have been lucky to have had reasonably good weather with minimal lost days due to rain, but we did have a couple of cancellations in Boggabri and Yamba.

With 2024 now complete and having mainly full fields, the exceptions being some of our regional weeks of golf struggling to get over 30 players a problem that we must address.

The 2025 Program is filling as we speak. I am awaiting several weeks to Nominate as they are having troubles holding onto their current TD's due to Management changes and natural attrition with nobody willing to step up and have a go. Moree have already cancelled 2025 and I believe Boggabri will do the same. We picked up Foster/ Tuncurry.

A request from our week of golf travellers that Young and Southern Highlands switch weeks so the order of weeks would be Harden, Young and Southern Highlands. This request was rejected by both clubs (emails attached).

Policy 2 is a work in progress and has several changes as had "Essential Elements". I believe that the Essential Elements paper has assisted all TD's in complying their Nomination Packs.

The 2026 Draft has been accepted across the board with minimal changes at this

I thank the Councillors for their assistance throughout the year with updates from weeks of golf. Our drop in numbers is a worry that must be addressed, and a minimal number must be established to run/hold a week of golf.

John Daley informed the meeting that Wauchope would like to revert back to the 2 days after Port Macquarie. Wauchope have been asked to formulate requirements Proposed pricing of Foster/Tuncurry was discussed, the meeting agreed the market should decide whether pricing is appropriate. This is beyond the remit of NSWVGA.

Accepted on motion of Steve Mitchell to adopt the program report Seconded Robert Trembath - carried.

General Business

AVGU Championships 2027:

For background the Licence agreement covers 3 parties: -

- 1. The Owner (AVGU)
- 2. The Licensee (NSWVGA)
- 3. Regional Division (Group 3 Illawarra Vets)

It was noted by Richard Farrant that there had been at least two changes made to the original contract.

- 1. Item 8 Owner approval At Least 18 months prior to the conduct of the championship the licensee will provide details to the Owner of the proposed golf courses to be used, prices to be charged, a copy of the draft budget, proposed dates for the championship and details and cost for the Presentation dinner and details of any involvement and intended use of a major third party for approval by the Executive Committee of the Owner. Progress reports must be provided at least every six months thereafter.
- 2. Item 10- Player Eligibility

To be eligible a player must be:

- . a financial member of a state or territory association affiliated with the Owner,
- . an amateur golfer having attained the age of 55 years
- . hold a current Golf Australia Handicap.

A partner of an eligible player who holds a current GA Handicap is eligible to enter the championship. Where the partner is less than 55 years of age, they will be eligible to win daily prizes only.

The Licensee must verify with the relevant state or territory associations that entrants are current financial members of that association.

Discussions ensued regarding these points which ultimately led to the need for NSWVGA to complete its own assessment of amended contract and clarify any identified matters with the Owner.

Richard Farrant submitted an undated copy of Licence Agreement signed on behalf of Regional Division in confirmation of the Regional Division's acceptance of Licence Agreement. Mr Farrant noted that future changes to the Licence agreement may be possible in consultation with the owner.

Richard Farrant presented a report on the progress towards AVGU Championships to be hosted by Illawarra in 2027.

Mr Farrant would not be drawn on budgets, proposed sponsorships or anticipated profits from the event indicating it was simply too early at this stage. To illustrate Mr Farrant indicated that although early approaches to prospective sponsors had been encouraging, none were in a position to commit until their respective 2027 Financial years when budgets would be finalised.

Mr Farrant did say that based on a number of arbitrary assumptions that initial indications as to entry fee was at or above \$400. This figure was based on 400 to 500 entrants.

Mr Farrant confirmed that venues for Welcome Reception, AVGU AGM and Championship Dinner have been booked. The nominated venue was HARS (Historical Aircraft Restoration Society Inc.)

Courses to be used for the event are

- 4BBB- Shoalhaven Heads along with The Grange.
- 54 Hole Championship Kiama- 3 days

Mr Farrant advised that based on advice received the organisers are in the process of registering a not-for-profit Incorporated Association. Amongst other things this should allow for the claim of GST paid to various suppliers which in turn will assist overall profitability of the event. This will necessitate an Inaugural meeting to formally appoint Office Bearers and to resolve to open Bank account(s). Suitable candidates and sub-committee representatives, across both male and female have been identified.

Mr Farrant indicated a desire for a Memorandum of Understanding to be established between the Regional Division and the Licensee (NSWVGA). This was considered essential given long lead time, that is office bearers may come and go but need to be aware of mutually agreed rights and obligations between all parties to the Licence Agreement.

A request that the Licensee have a position on the Board/Council of the Regional Division was accepted by Mr Farrant.

Mr Farrant sought a commitment to advertise the Championships on the NSWVGA website and that a suitable space be allocated to the Championships in the 2027 Calendar.

Mr Farrant believed the existing Insurance extended to the Regional Division by the NSWVGA under existing Insurance Policies would cover the event. Mr Farrant requested the NSWVGA confirm this with Insurance Brokers and suggested Candice Gilchrist as a point of contact.

Mr Farrant sought a commitment from the NSWVGA as Licensee to provide Seed Capital to at least \$10,000 in terms of the Licence Agreement. Mr Farrant noted that he felt this would bring the total commitment by NSWVGA to a total of \$15,000 as the payment of Licence fee had been agreed to 12 months ago.

After some discussion it was agreed that the Licence Fee was to be retrospectively within 60 days of completion of the event and therefore the total commitment sought from the NSWVGA was more appropriately \$10,000.

It was further agreed that the NSWVGA as Licensee was assuming all of the short-term risk and the provision of seed capital that some form of compensation for this funding would be appropriate. Subsequent discussion canvassed several alternatives however no agreement being reached it was agreed to pursue this through memorandum of Agreement.

Gary King that NSWVGA as Licensee, defer signing the agreement until we seek clarification on all points identified as a result of completion of due diligence.

On motion Clr Gary King Seconded President John Daley - carried

NSWVGA Stroke Play Championships

Clarification was sought on comment by representatives for 2027 AVGU Championships Committee that they had already been awarded NSWVGA Storke Play Championships from 2026 for 3 years. Following some further discussion amongst Councillors and Delegates it was resolved to further investigate historical minutes to clarify and to notify all affected parties, including recent EOI submission.

Review of Policy 2

Discussions covered:

- Standardised format
- Definition of "Major" prizes as stated in Policy 2
- Elevation of NSWVGA Shield to a more prestigious status

During these discussions some historical references to former Policy 2 directives regarding format were made. Additionally, several examples of different approaches to the awarding of prizes at various weeks of golf were provided. These examples discussed a wide range from interpretation of "major" prizes to how the NSWVGA shield was promoted by various Tournament Directors as a means of establishing relative status of shield event.

It was resolved that Penny Hudson and Jim Shadlow would look at re-drafting Policy for review by Executive Council at a future meeting.

Policy 5

An apparent exception to Policy 5 in the timing of trial Guyra Week of Golf was raised. In response a review of the timing of several events in the future Calendar of events may be appropriate.

NSWVGA Matchplay Championships 2026 to 2028

As the only application received for the Match Play Championships was received from Port Stephens, it was agreed to award to Port Stephens. Some adjustment to dates may be required to allow for flow onto to nearby events such as Foster/Tuncurry.

NSWVGA Fourball Sandgreen Championships 2026 to 2028
