Presidents Report April 2025

The past months have been busy with weeks of golf the website and various other matters concerning NSWVGA.

Weeks of Golf.

Over the last two months I have managed to attend several weeks of golf from Shoalhaven Heads to Tumut and all in between.

Only on one occasion were the numbers poor and I hope that this has been addressed with suggestions to the Tournament Director as to how the attendance may be improved.

There is a new generation of veterans attending weeks, which augers well for our future.

The Sand green Championship was a week of note, being its inaugural week and the numbers attending quite acceptable for the first attempt by Walcha. Peter Taylor needs to be congratulated on the success of this week because it has not been easy, but his persistence has paid off.

Nomination Packs

The time taken to approve nomination packs needs to be reviewed. The Tournament Directors are giving plenty of notice with their nomination packs but there needs to be more urgency on our part to place them on the website.

Insurances

We have three insurance policies that cover us as the Executive, but this doesn't include our vets playing veteran's golf. We need to and are in the process of obtaining a clear picture from Golf Australia as to where we stand on this matter.

Future Members of the Executive Council

We will be losing very experienced councillors at the end of the year. We need to start canvassing veteran groups for replacements. I would ask all councillors officiating at weeks of golf and group events to mention there will be vacancies at the end of the year and to include a small segment in their talk on this matter.

Grass Roots Scheme

We have received a detailed letter from Central West veterans on grass roots and various other points of how we do business. This will be discussed at the April meeting but our decision to revamp the scheme

needs to carry on. Attached is a letter and nomination form to go to Group Secretaries. This needs to be discussed at the April meeting and a decision to implement or revamp made.

AVGU 2027 Tournament.

Richard Farrant will present an up-to-date account of where we are with the planning of this event. His committee meet regularly so I look forward to hearing the progress made.

Flooded Northern Rivers Group

The recent cyclone has left considerable damage to golf courses in the northern rivers area. Struggling towns such as Lismore, Coraki, Woodburn-Evans Head and Grafton have all sustained different levels of damage that will affect their ability to resume playing.

Group Secretary Ray Kent will update how clubs are coping and what level of support NSWVGA can offer these clubs to get back on their feet.

I have also approached Golf NSW as to what they intend to do to assist in this area.

April Meeting

Catherine Pautsch has been spending many hours with Councillors bringing them up to date with our new file sharing and meeting program.

We will trial a new Team Meeting format in April as well as the new file sharing with reports etc.

Thanks Catherine, for all your hard work in this area.

Policies

Finally, Policy 2 should be able to be ratified and replace the present policy on the website. Thanks to Penny and Peter for this.

The Program co Ordinator, Steve, will then attach the revamped policy with his email to TDs for the remainder of this year and leading into 2026

Upcoming Meetings

Our Executive team meeting will be on April 9th at 9.00am, and the June meeting will be a face-to-face meeting at a new venue, Beverly Park Golf Club. Aileen has set this up and we will visit the venue on the Tuesday before the meeting to ensure every is ready to go.

Treasurer's Report NSWVGA Executive Council Meeting 9 April 2025

Peter Taylor sent form to add signatory to the Bendigo account. Peter has since posted to Bendigo late February or early March. As yet he has not been added. My enquiries have failed to trace form. We will begin process again.

Financials Spreadsheet with instructions sheet now shared with Rob Trembath and Peter Taylor.

Once naming conventions and hierarchy agreed to, I will commence renaming and filing of documents in new shared folders in NSWVGA One Drive.

Manuel Pro's Feedback. This is the second time this calendar year that I have been in receipt of robust feedback on the level of reserve funds currently held by NSWVGA. Additionally, there has been a lot of commentary relating to changed "Grass Roots" scheme. The two matters are of course related. This means we need to be more effective in communicating the key message we are looking to do more to ensure value to all NSWVGA members, not just those attending weeks of golf. I would like a conscious effort by all future NSWVGA Reps at Weeks of Golf to speak about the Grants program.

A key point we need to stress when discussing the NSWVGA financial position is the intention to return surplus funding to all members over time at a sustainable level.

Having said this it cannot be stressed enough that without the support of those travelling regularly to respective weeks of golf the NSWVGA would cease to be relevant. This is a point missed by Mr. Pro in his feedback.

However, Mr. Pro does make a vital point that there does need to be more balance in how value is provided to all members regular week of golf attendees or not.

To this end a priority must be to encourage applications under the Grants scheme. We need to agree on the nature and form of application and circulate application forms as part of next Newsletter. Timely decision on respective applications will also be important; applications are not held over for discussion at EC meetings every two months. I propose that applications be directed to the Treasurer email address. As the come in, they are shared via internal "councilor's" email address for feedback to Finance Committee on relative merit of applications. Finance Committee to re-commence Monthly meetings to discuss and agree on successful applications and be delegated to commit funding. Again, councilors must speak to this at every Week of Golf in coming months.

I have attached a separate suggestion for Application for NSWVGA Grant. This is an initial suggestion, and I am sure can be improved upon.

I am comfortable in addressing specific finance questions from Mr. Pro in our formal response. I can work with President John and Secretary Aileen on this.

<u>Insurances update.</u> Councilors would have seen my email of 3 March in which I detailed discussions with Craig Fretwell an insurance consultant, thank to John Dixon for the introduction. For some time now we have been concerned that we may be doubling up on Public Liability Insurance, Advice received from Mr.

Fretwell but also and advice received by Colin Thornily of the AVGU from Mr. Joshua Ward of Marsh Insurance Brokers (Insurance Providers to Golf Australia) on 15 November 2024 it appears that it is prudent to hold Public Liability insurance not only on behalf of the NSWVA but also on behalf of affiliated Clubs and Groups mentioned on our policy schedule. There has been an incident at the Central West Week of Golf which, as the claim process continues, may provide clarity on future Insurance needs.

Members Register Reconciliation This remains an insurmountable problem due to a large number of deposits for \$5 and \$10 as more people seem to be moving towards direct deposit. Of the 217 separate Deposits received to date this year 62 (or just under 29%) of the deposits have been for \$20 or less and 32 (or just under 15%) have been for \$5. Additionally, of course, even with larger group-based transactions there is quite often a separation of duties between payment of fees and recording of members in the MR.

NSWVGA TECHNICAL REPORT – APR 25

1. Email addresses

Everyone is asked to send all items related to the website – tournament entry documents, news items, tournament results, contact detail changes, etc – to webmaster@nswvga.com.au and not to any individual email address. This way these will get to the correct person to handle them.

There have been numerous occasions in the last month where emails have been going to spam when coming through forwarded email addresses. This was not happening in the past.

The forwarding is also becoming more unreliable, sometimes it works correctly and other times

The situation is becoming more critical that we have to find a solution.

We think we may have found an alternative method of re-direction, and Peter will test this using his personal domain on google and set up automatic forwarding between his different email accounts. If this option works, we will move our domain registration and re-direction away from Intercomp.

In the mean time, Catherine is maintaining a master list of email addresses and anyone who wants to send emails to these categories should get the up-to-date list from Catherine each time. Please do not use privately maintained lists.

2. File sharing – Microsoft OneDrive

The NSWVGA OneDrive is being set up. Catherine Pautsch is the main administrator with Peter Guy as backup.

Every councillor now has view access throughout the NSWVGA OneDrive shared files.

Over the last month a number of folders and files were set up in OneDrive for all councillors to test that the viewing and editing features work correctly for them.

The Minutes folder has been placed in OneDrive and will be used for the April meeting.

As some internet connections are slow it may take a few minutes for OneDrive to update files so please be aware when using it in the future.

A document with the proposed folder structure was distributed to all councillors for comment. This will accommodate all our documents and files, together with file naming conventions and procedures. It also shows access levels to the different folders for all councillors.

Councillors will have edit access to folders as required for their duties.

Once all suggestions have been received the file structure will be finalised and setup for use. Once set up folders need to populated with historical data where relevant.

3. Meeting software - Microsoft Teams

During the last month all councillors have used the Teams app, in one-on-one discussions with Catherine Pautsch. Most councillors also joined a group discussion testing the Teams app ready for the next meeting.

There is a feature in Teams which allows a meeting to be recorded and transcribed. This would be very useful to the secretary. Upon investigation this feature only comes with a Business package which can be purchased for \$9 per month. Approval for this is required.

4. Public website

At the moment on the Public Website we have two areas News and Results which are in the main duplications of each other. We should consider combining both of these.

Currently the newsletters are not on the website. If we want them on the website we should consider the following 3 options:

- have it's own tab replacing current Results
- under "About Us"
- as a news item under current news.

Our website will not accept any documents or pictures over 5Mb, and even items this large are difficult to manage. It is not necessary to have high resolution for a website – low to medium resolution is quite adequate. All contributors ae asked to try and keep each document or picture to 1Mb or less.

5. Membership Register

When a user finds a GL number that needs to be changed for any reason or deleted, they must send the full details to membreg@nswvga.com.au. Please do not just add the member again with the new number – this results in duplicate records which then need correcting.

Up till now our clubs table has been created from a table downloaded from Golf Australia, The webpage has disappeared and we have had difficulty in getting an official up to date version. We are trying to progress this through other contacts.

We are still in discussions on what is the best way to proceed with development of additional functions, taking account both costs and providing a good basis for future changes. Additional functions are required to make it easier for administrators to correct errors.

We have a spreadsheet to produce lists by Affiliation Group or by Club if required by Group Secretaries.
