## Presidents Report June 2025

### Overview

NSW has been experiencing extreme wet weather along the east coast over the last six weeks which has had a devastating effect on veteran's golf at all levels. We have lost some weeks of

golf as well as the veterans events at club and group level. The damage that the rain events have had on townships along the coast and in some inland areas has been devastating. Our Secretary, Aileen, has sent out an email looking for ideas of support that NSWVGA can offer to our veteran golfers at this time with the replies varying as to how we can assist. This will be discussed further at our June meeting.

#### Travel

Over the last three months I have be able to travel to the South Coast, Blue Mountains, Central West, Riverina and Western areas participating at weeks of golf, Open days and weekly club events conducted by our veterans. The results have been mixed with the following evident as to how vets events are conducted, and we as the Executive are perceived.

Firstly, it is evident that the Groups are not aware of the support that is available to them at club and Group level. An example of this is the Groups do no conduct championships and are not aware that we have a policy in place that will support such events as Stableford and 4 ball stableford events. I have spoken to Group Secretaries and have sent them the policy concerned with this.

I was heartened to find that old prejudice between towns has diminished greatly and that veteran groups seem to be interacting far greater on a weekly basis than was the case in the past . An example of this is Forbes and Parkes now conduct a week about event between their vets clubs.

There were examples of veterans at club level who are "switched on" and providing an outlet of activity for the vets at their club and the district. They have their vets day as well as several working bees at their club each month which serves their golfing community well.

It was good to be able to meet Group and Club secretaries and for them to be able to put a face to the name. These volunteers are doing an exceptional job with veterans golf, but they need support from us the Executive to make their job as easy as possible.

# Half Yearly Face to Face

This is an opportunity for us to review how we have preformed over the first six months of the year and the areas that need to be improved. We need councillors to give some thought as to what is working and what is not and how we can improve on this.

### **AVGA**

The A.V.G.A (Australian Veterans Golf ASSOCIATION) a change of name from the half yearly ZOOM meeting just conducted. There were four main agenda items discussed, and the minutes of this meeting are available on the new Business One Drive under reports. This will also be an agenda item.

## A.V.G.A. Championships 2027

There have been meetings at which our representative, Charlie Sawyer has represented NSWVGA. There will be a report tabled at our June meeting with a representative of the steering committee.

## Roles and Responsibilities.

All councillors, when they came onto the Executive were aware that when they put their hand up, they would play a role on the Executive in some way. As a past President pointed out "when you come onto the Council you don't come to warm a seat". Just what this role is, has never been clearly defined. Penny has been asking Councillors to define their role. I am asking Councillors to put some effort into this and have some notes to discuss at the June meeting. There are some roles described in the policies, some in the Constitution but nothing that somebody who wants to know how we operate and maybe be part of the Executive can access. This will be an agenda item.

### **Grass Roots**

A meeting of the Finance committee was held in late May to discuss the first applications for grass roots assistance. In all there were four submissions received. It must be stressed that the

grass roots are to assist veteran clubs throughout the state , not to replace infrastructure at golf clubs.

The outcomes of the meetings will be an agenda item at the June meeting.

As can be seen from this report there is plenty happening and the June meeting will a very busy one. This meeting will be held at Beverly Park Golf Club on Wednesday 11th June at 9.00am-those attending be aware it may be longer than normal so book your travel accordingly.

# Treasurer's Report NSWVGA Executive Council Meeting 11 June 2025

<u>Finance Committee</u> - Finance Committee have only had the one meeting to assess and award Grass Roots Payments, more immediately below.

Grass Roots - Only 4 submissions relating to Grass Roots to date, this is a disappointing take-up when it is considered NSWVGA comprises 30 Groups. Of the 4 submissions received 3 were applications and one was by way of feedback disagreeing with the changed direction of format. In dealing with the feedback first of all, I have sent an email on behalf of the Finance Committee acknowledging feedback and also to try to further explain rationale for the change. The email also included an invitation for the submission for a grant as the correspondent appeared to believe their Group would not qualify for the new Grants scheme. Of the remaining 3 submissions one has been approved, this being Southern Riverina a second being for Central West has been favourably received however additional feedback on the nature of a proposed Tournament(s?) has been sought, I am awaiting further information. The third submission being from Sydney Vets was declined as it failed to demonstrate any hardship, how a grant would benefit a struggling Veterans Golf Club or how any funding would further promote the increased participation inf Veterans golf. The Sydney Vets have been invited to resubmit an application if they have a case under these broad guidelines. In short though I appeal to Tournament Directors to continue to speak for the Grants program at upcoming weeks of Golf. We also need to emphasise that the NSWVGA Grants are for the benefit of local Veterans clubs and not designed as financial assistance a Golf Club's broader membership to assist with Flood recovery or similar.

<u>Members Register Reconciliation</u> Following Teams meeting with Rob Trembath and Peter Guy t was agreed that the Treasurer would recommence attempt at reconciliation between Financial receipts and membership updates in the Members Register. This task will continue to be complicated by the crosse over between Financial Year, Membership year and the amendment to Membership year whereby affiliation fees received after 1 July spanning two Financial and Membership years.

YOY Financials – Income total is broadly in line with previous year to date. Note however that Sydney vets' group have overpaid affiliation fees to by \$3,005 in the changeover between Treasurers. Incoming Treasurer having identified overpayment of assuming the role. A refund of overpaid affiliation fees has been made in June. In terms of comparative Expenses, this year's Expenses ytd end May are \$7,847 above previous year. After adjusting (reducing) previous year expenses by non-recurring expense of Purchase \$1,574 of NSWVGA Laptop for use by Secretary, this would suggest an increase of \$9,421 in expense YOY. This increase includes payment of \$10,000 to the 2027 AVGU National Championships Committee recorded under sponsorships.

Other Matters – Efforts to add Peter Taylor to Bendigo bank continue with previous paperwork having been misplaced within Bendigo Bank. Treasurers Duties, this document continues to be a work in progress, I anticipate it will be complete by end of June. Teams meeting protocol this document will be loaded onto share drive for review, comment and suggested additions.

This way these will get to the correct person to handle them.

Where "SPAM" is shown in the subject of an email, this will have been put in by the recipient's email provider. If you forward or reply to an email that was received with "SPAM" in the subject, edit the subject to remove the "SPAM before sending it.

The forwarding is also becoming more unreliable, sometimes it works correctly and other times not.

The situation is becoming more critical that we must find a solution.

We think we may have found an alternative method of re-direction, and Peter will test this using his personal domain on google and set up automatic forwarding between his different email accounts. If this option works, we will move our domain registration and re-direction away from Intercomp.

Rolling out the OneDrive remotely has been a challenge and most councillors have the correct access. There are a few that still need connecting and hopefully this will be done at the council meeting.

When populating OneDrive the agreed file naming conventions and procedures should be used. Folders need to populated with historical data where relevant.

As some internet connections are slow it may take a few minutes for OneDrive to update files so please be aware when using it in the future.

# **Meeting software - Microsoft Teams**

The new Teams App has a feature which allows a meeting to be recorded and transcribed. This was tested by the Secretary Aileen, President John and Catherine Pautsch and worked well. It will be used for Council Teams meetings.

## **Public website**

The two areas News and Results will be merged but this will take some time. Our website will not accept any documents or pictures over 5Mb, and even items

this large are difficult to manage. It is not necessary to have high resolution for a website – low to medium resolution is quite adequate. All contributors ae asked to try and keep each document or picture to 1Mb or less.

When a user finds a GL number that needs to be changed for any reason or deleted, they must send the full details to <a href="mailto:membreg@nswvga.com.au">membreg@nswvga.com.au</a>. Please do not just add the member again with the new number – this results in duplicate records which then need correcting.

Up till now our clubs table has been created from a table downloaded from Golf Australia, The webpage has disappeared and we have had difficulty in getting an official up to date version. We are trying to progress this through other contacts. We are still in discussions on what is the best way to proceed with development of additional functions, taking account both costs and providing a good basis for future changes. Additional functions are required to make it easier for administrators to correct errors.

We have a spreadsheet to produce lists by Affiliation Group or by Club if required by Group Secretaries.

Progress report for 2027 AVGU Championship

### General Business:

Pres John Daley gave a verbal report on the AVGU delegate meeting.

The AVGU requested to change their name to AVGA (Australian Veteran Golfers Association) when registering the association in Western Australia.

Life member Bob Coulson informed the meeting of the issues that the AVGU might experience when trying to register the new name, as the Australian Veteran Golfers Association. This name was registered to another golfing group that travelled the world playing golf. Pres John Daley will inform the AVGU Secretary of this information. The other suggestions that were made was for all the states to come under one group for insurance, logo and a team event competition separate to the National Championships.

Insurance- was proposed and defeated.

National Logo: All the states will continue to use their own logo, but will also promote that we are all a member of the AVGU.

#### The team event:

Each state would provide a team of players to compete against each other. This was discussed at length but in the current format , rejected. Clr Robert Trembath put forward a suggestion that as there is currently a Championship played by all states each year. Then a team from each state could play concurrently along with the Championship. This will be discussed once again when the AVGU delegates meet at the AGM in Darwin later this year.

Professional indemnity Insurance- Clr Gary King enquired as to why the AVGU would require professional indemnity Insurance. The only meeting that the delegates hold face to face is once a year at the AGM where they are covered under that state's insurance. NSWVGA are not in favour of a national professional idemnity insurance.

Group Secretary Discussion points forum:

Some Group secretaries would like to be able to make more changes in the members register. Group secretaries would like to be able to get a list of members in each of the clubs in their groups.

Group secretaries would also like to be able to change member golf link numbers. As a lot of incorrect data that was carried over from the old members register has been filtered out. It was then felt to give multiple access to behind the scenes of the members register would then recreate some of the previous issues . If group secretaries need to make any data changes, then they can send the changes that they want made to the members register into and they will make the changes on their behalf. ## Forster /Tuncurry:

Forster/Tuncurry requested to change their WOG date in the program, 2026 (13<sup>th</sup> to 17<sup>th</sup> July) As this year's week was badly affected by the weather.

Players entered for the tournament via Google golf which crashed. This caused all player entries and player information to be lost.

There were concerns with the weather which was relayed to management but Clr Peter Taylor was assured on the Thursday prior to the event that the week would go ahead only at Tuncurry as Forster course was closed. Due to the inclement weather on Monday morning only nine holes was able to be played and the rest of the week was then cancelled.

It was requested by management for the players to pass on their information so that a 3-day golf and presentation night be refunded. There was a strong feeling that the week of golf could have been cancelled a lot earlier prior to the event.
