File Sharing between councillors:

Clr Catherine has opened a NSWVGA stand - alone One Drive.

Clr Peter Guy will over the next week decide the initial top file structure. Catherine will contact each councillor and walk them through the process.

Councillors Peter and Catherine will send out an email to all councillors as to what operating system they are currently using. Note all councillors will have read and write access to all files. But all councillors will have read access.

The Microsoft 365 licence gives us access to Teams. This would also reduce our cost in Zoom meetings which currently cost app \$240.00/ \$250.00 each licence

Councillors Gary King and Peter Guy are currently using two licences. If it is practical we may change over to Teams. Vice President John Dixon stated that Teams is practically the same in usage as Zoom. Clr Peter Guy may set up a similar process with Councillors

as what was done when we first started using Zoom. Clr Catherine will have to train Clr Peter in using teams first.

Membership Register.

To reduce duplication of names in the members register the bulk update template has been changed. As some people have noticed that some of the names in the members register have extra spurious spaces in them.

Remove the wording Under the Auspices of NSWVGA from NSWVGA documentation and replace it with the wording Under the guidance of NSWVGA

This will include both Stroke and Nett when awarding trophies.

A Balance sheet is no longer required but a written report is to be forwarded to the NSWVGA Secretary.

To enter all NSWVGA events Men or Women must be 55 years of age or older at the time of entry.

Reports:

Presidents Report February 2025 - ZOOM Meeting

Overview

We have just commenced the 2025 week of golf program. Hawks Nest is completed, and Shoalhaven has commenced. Both events are at capacity ,numbers wise , with Councillors represented at these events and all events till the June break. It is pleasing to see that councillors attending, while not the official representative, are helping out at registration.

Week of Golf Registration

It is apparent that numbers of veterans entering events are coming up as unfinancial in the bulk downloads. While in a lot of instances veterans are coming up as unfinancial this may not be the case as the problem may lay with updating the members register.

It would be hoped that if this information is obtained in a timely manner so as Group Secretaries can be notified and provide up to date information concerning the veterans in their Group. A good example of this was in our first event of the year some 90 unregistered vets showed up in the bulk download. To further exacerbate the problem a number of veterans came from the one group and the Group Secretary couldn't be contacted. Only the diligence of one Councillor rescued the situation. We will talk about this at the ZOOM meeting.

Grass Root Scheme.

It is my intention to discontinue this with the Executive's agreement and replace it with requests from Group Secretaries to support struggling clubs in their Groups. This can be achieved by a request and a hardship case presented to the Board with each case determined on its merits. An example of this is if a struggling club needs support to run an Open Day and are lacking in funds then NSWVGA could assist in this area.

While the money from past Grass Root schemes found it way to some destitute clubs there was a lot of money sent to clubs who were financially well off.

2027 AVGU Championships

The Agreement presented by Secretary AVGU, Colin Thornily, has been signed and returned to Colin. This was not taken lightly with a number of questions presented to the AVGU for clarification and a Memorandum of Understanding presented to Illawarra Veterans as to what we as the Licensee require and expect with the running of this event. After many constructive phone calls and emails NSWVGA (Licensee) and the 2027 AVGU Championship Association (Illawarra Veterans) have agreed on this document and it will form part of the Constitution being prepared by Richard Farrant, Chairperson, which will show the way forward with the preparation of this event.

There will be a report presented at this ZOOM meeting by Richard's committee.

Insurances

As outlined in the treasurers report our Treasurer has done an enormous amount of work on NSWVGA Insurances with what we are and are not covered for.

Basically, we cover all volunteers and councillors associated with Veterans golf in NSW, but we do not cover veterans attending weeks of golf.

Golf Australia issued a statement in late December outlining who was and who was not covered under their umbrella. Basically, what it boiled down to was, if you were affiliated with Golf Australia then you were covered as an individual but then they outlined what was not covered. It dealt mainly with personal items such as range finders, carts, clubs etc but they then mentioned the word 'AUSPICES"

Their definition of "AUSPICE" was to provide support, sponsorship or guidance. It then went on to talk about risk and insurance as being an important consideration when working with other organisations.

Gary put a scenario to Golf Australia which included an outline of our week of golf and the fact that we as the AUSPICEE do not organise venue, the event or the overall funding, only a partial funding for our Shield.

The answer back was that if you are affiliated with Golf Australia then you are covered, there was also a link to the definition of AUSPICING.

Our initial reaction is to remove the word AUSPICE from our policies and replice it with a word such as GUIDANCE. It applies mainly to Policy No 2. This needs to be discussed at the meeting this month. As a background ask your club if you are covered by their insurance??

Policy Updates

Penny, with the assistance of Jim Shadlow has been working on policy 2, with the aim to look at making the NSWVGA Shield the major focus of the week of golf. There is also changes to be looked at as far as insurance is concerned.

She is also working on policy 6, Sandgreen Championships which she will talk about at this upcoming meeting as an agenda item.

Members Register

The document, Members Register User Notes, has been sent to Group Secretaries for comment. This has been a painstaking project but the benefits it will provide to Group Secretaries a clear course of action between the Group and the Executive. After feedback and modification, if needed, this will form the bulk of Policy No13 which will be displayed on the website under policies as well as an attachment to the Members Register. Many thanks to Peter Guy and Rob Trembath for your efforts.

It has been a quite start to the year, but things will start to accelerate as they do with veterans golf. I am looking forward to catching up with councillors at different events in the first half of the year. Remember there is a Zoom meeting on Wednesday 12th February.

Have your reports into Aileen the week before and if you have an agenda item any information you can provide prior to the meeting will keep discussion to the point and ensure the meeting keeps on track and finishes at a reasonable time.

Treasurer's Report NSWVGA Executive Council Meeting 12 February 2025

Update on matters arising Executive Council meeting 4 December 2024-

Microsoft 365 – As previously advised Family account has been set up in the name of NSWVGA and my name. I have tried sharing files with someone without a Microsoft account successfully. Thay have with my approval edited files and returned them to me. This was achieved without having any form of Microsoft account by the recipient (Leesa King), and editor, of the files. Following admitting Catherine Pautsch to the family group on late 2024 Catherine and Peter Guy have been exploring utility of the Family Group as a vehicle for file sharing by NSWVGA. I am not privy to all the work done by them but at their request I explored possibility of establishing a centralised "room" in which to place folders and files for subsequent use by Councillors. I was also asked to explore the possibility of sharing Admin duties for the family group in the case of anything untoward happening to the administrator (me in this case). I spent some time exploring these possibilities and in the end happened across various online Tutorials which confirm that it was not possible to establish a separate Date Room for common use amongst family members and that individual family members (in our case the individual councillors) would be required to manually transfer files allowing the recipient to edit and return to the original file holder.

This does not, in my view meet NSWVGA needs. The tutorials also confirmed that there is no administrator function within the Microsoft 365 Family package, simple the ability to add or remove people. Again, this raises the concern of obsolescence as councillors are appointed and "retire" from the council. I have since advised Catherine and Peter of my findings whilst also confessing I was now well and truly beyond my competency levels and deferred to them to further investigate and report their findings to the Council for approval of next steps.

Insurances Review – The NSWVGA currently holds three Insurance policies through Warren Saunders insurance brokers. These policies are Public/Products Liability Insurance, Association Liability and Volunteer Workers Insurance. The scope of these insurances was provided by Lance Fredericks in a paper dated 15 June 2022. I will provide a copy to Aileen separately for discussions as required at this EC meeting. The Insurance review is currently being conducted on two fronts, with a possible third party to be approached to assist with review. To date I have sent emails to Candice Gilchrist from Warrens Saunders Insurance Brokers, on 14 January and a follow up email sent to both Candice and Courtney On 23 January. The email simply requested three scenarios covered under the respective policies held by NSWVGA and how the policies held would mitigate claims made against the NSWVGA. The purpose of the initially broad questions was to assist with the formulation of more targeted questions relating to each of the policies held. As at the time of writing this report I have received a partial response from Warren Saunders Insurance Brokers in relation to one of the policies only. I will revert seeking additional clarification on that policy but also to follow up on the remaining policies. The second line of the review is related to the first as far as it relates to the level of cover, if any, participants in Weeks of Golf hold. To assist in this review, I sent a specific case scenario to the Club Support website of Golf Australia. As John Daley was included in correspondence, I will leave it to him to provide specifics of scenario as required by the council. The result of this enquiry was confirmation that any participant who is a paid-up member of a Golf Club affiliated with Golf Australia is covered for Third Party Liability as outlined in Golf Australia website whilst playing or practising golf anywhere in Australia and New Zealand. It should be noted that only members of Golf Clubs affiliated with Golf Australia are eligible to hold a Golflink number.

Financials and Bank Reconciliation to 27 January 2025 – Given my current absence I have completed report to 30th January rather than end of month. Given this represents the first four months of the year only the data is interesting rather than informative. Particularly given that from an income side many of the clubs and groups make their annual payments for affiliation fees as of 31 December. Income is down approximately \$7,000 Year on Year (YOY), it should be noted that fees for the largest Group by member numbers, Group14 have not yet forwarded affiliation fees where this payment was received late in January 2024. Expenditure is in line with previous YOY. Week of Golf Prizemoney distributed up to Illawarra Week of Golf. I will initiate contact with Blue Mountains and Central West whilst travelling, as time permits.

<u>Addition of Peter Taylor to Bendigo Account as signatory</u> in his capacity as a standby Treasurer in the event of incapacitation of myself and or Rob Trembath. Paperwork is with Peter, who has I believe lodged with Bendigo for processing.

Items for discussion at EC.

- Replacement of the use of "Auspices" with an alternative term such as "guidance" or "support" or a term such as "in accordance with NSWVGA Policy 2 guidelines" President john can speak more to this.
- Review of Insurances on 30 January I received a partial response from Warren Saunders which relates to the Public Liability policy. This is the one over which greatest review is required. The response received on 30 January requires additional clarification, I will continue this process on return from overseas trip. Golf Australia Insurance changes, I will ask John Daley to speak to this as required by EC during meeting.



NSWVGA INSURANCES Paper for Council Meeting, 15 June 2022

NSWVGA holds three insurance policies which cover all Club, Tournament & Group Committees and NSWVGA Council for Association (Public) Liability, Voluntary Workers and Management Liability. The Association Liability policy is with Sportscover, a syndicate of Lloyds. Sportscover is also the insurer for the Golf Australia personal liability insurance. The other two policies are with DUAL, another Lloyds syndicate.

The insurances have been in place for a number of years and the premiums are a significant item in the NSWVGA annual expenditure.

Association Liability (Public Liability)

Annual Premium: \$7,292.29

Cover Details Public Liability Products Liability

\$20,000,000 any one occurrence \$20,000,000 any one occurrence

and in aggregate Professional Indemnity Not Insured

Golf Australia has a Personal Liability Insurance policy which covers all affiliated golfers.

The Public Liability policy covers all Vets Committees. I have had a recent query as to coverage from a Vets Committee (Through Jim Shadlow) who had been informed by the Golf Club that their activities were not covered by the Golf Club's policy. I do not know the terms of any Gof Club's public liability insurance.

If our banner falls and causes injury then the Vets / Tournament committee would be covered against a claim should the injured person yake action against them for putting the banner up and not securing it.

More than one local Council requires proof of cover when sponsoring a WOG.

I am not aware of any insurance held by Golf Australia or Golf NSW which provides any cover to any Veterans Committee.

Voluntary Workers

Annual Premium: \$1,458.60

Insured: All Club Directors, committee members and Voluntary Workers of the insured aged under 85 years.

Scope of Cover: Whilst an insured person is engaged in voluntary work or attending meetings authorised and under control of the insured includin direct travel to and from such authorised activities.

Aggregate Limit of Liability: \$1,000,000 during the insurance period.

The policy lists maximum payments for specific circumstances including excess where applicable. These include Accidental Death, Injury requiring surgery, Weekly benefits, Fractured bones, Dental benefits, Non Medicare benefits, Domestic home help and others. In each case there is a maximum benefit either

as a lump sum or weekly payment with a limit on time (no. of weeks) or amount. The Aggregate Limit of Liability is \$1,000,000 for all claims in a year.

A participant in a WOG is not covered as he/she would not be seen as a voluntary worker. A person driving to the WOG to assist in running the WOG (Spotter, Scorer, Starter etc.) woul be covered.

A NSWVGA Councillor travelling to a WOG where the councillor was to present trophies would be covered.

Management Liability.

Annual Premium: \$2,191.09

Limit of Indemnity: \$2,000,000 in one claim and \$2,000,000 in the aggregate of claims during the insurance period.

The \$2 million claim limit, either singularly or in aggregate, is possibly the minimum cover obtainable for such a policy. The total turnover of all Vets Committees in NSW is hard to estimate but the insurer has been made aware of our structure and how mem, bership fees czn go through three sets of books together with what other monies might go through the varios committees' accounts.

This policy covers Veterans Committees against losses from Fraud, Crime and other specified costs involved in recovering a business after a specified event as well as court and legal expenses flowing from an event.

There are about 39 pages in the policy wording document setting out detailed coverage and exclusions which are not easy to summarise or condense.

The policy does not cover Cyber Crime which the previous insurer's policy did for the last three or four years. DUAL offers a separate policy for this cover which costs about \$1,600.

I do not recommend that we take up this policy as we do not operate a main computer system which could come under attack or in which ransomware be clandestinely installed.

1. Email addresses

have been put onto the Home page and Executive Council page of the website.

Everyone is asked to send all items related to the website – tournament entry documents, news items, tournament results, contact detail changes, etc – to webmaster@nswvga.com.au and not to any individual email address. This way these will get to the correct person to handle them.

We have not yet been able to set up automatic re-direction for emails to Group Secretaries, Club Secretaries and Tournament Directors. Catherine is maintaining a master list of email addresses and anyone who wants to send emails to these categories should get the up-to-date list from Catherine each time. Please do not use privately maintained lists.

2. File sharing - Microsoft OneDrive

File sharing has two objectives:

- to allow multiple people to work on a single central copy of certain files;
- to ensure that all NSWVGA files are securely archived and available for whoever needs them without dependence on individuals and specific devices.

We have purchased a Microsoft Office 365 subscription in the name of NSWVGA which allows us to use Microsoft's OneDrive for file sharing. Catherine Pautsch will be the main administrator with Peter Guy as backup.

We have done a series of tests and have confirmed that we can successfully share both files and complete folders for both viewing and editing.

We are developing the file and folder structures to accommodate all our documents and files, together with file naming conventions and procedures for use.

Over the next weeks we will be contacting individual Councillors to determine each person's operating set-up and to test that they can successfully access files in OneDrive.

3. Meeting software - Microsoft Teams

Our Microsoft Office 365 subscription gives us access to the Microsoft Teams meeting app. If we use this for our meetings, we can dispense with the Zoom subscriptions that we currently use.

In parallel with checking out the use of OneDrive with each Councillor, we will also be checking out the use of Teams with a view to using it for the next meeting in April.

4. Membership Register

It has been pointed out that there are a number of instances where first or last names have spurious spaces or other non-printing characters in them. This causes names that are apparently the same to be reported as different. The Bulk Query and Bulk Update templates have been changed to remove spurious characters from the input so that entries in the future will be OK.

The Q&A document has been distributed to all users and it has been loaded up onto the Register website for download.

When a user finds a GL number that needs to be changed for any reason or deleted, they must send the full details to membreg@nswvga.com.au. Please do not just add the member again with the new number – this results in duplicate records which then need correcting.

We are still in discussions on what is the best way to proceed with development of additional functions, taking account both costs and providing a good basis for future changes. Additional functions are required to make it easier for administrators to correct errors.

We have a spreadsheet to produce lists by Affiliation Group or by Club if required by Group Secretaries.

5. Public website

Our website will not accept any documents or pictures over 5Mb, and even items this large are difficult to manage. It is not necessary to have high resolution for a website – low to medium resolution is quite adequate. All contributors ae asked to try and keep each document or picture to 1Mb or less.

The 2026 program was loaded in early January and the 2024 Program was archived.
