### **Reports:**

#### ***Presidents Report February 2026 NSWVGA Inc***

##### ***Overview.***

Welcome all veteran golfers to 2026. This will be an exciting year and a year where there will be changes to the way we operate and this will better serve Veteran golfers throughout NSW.

##### ***Group Secretaries Forum***

This was held in January 2026. My thanks to the members of the Executive for their help, involvement and feedback from the forums. My thanks to Vice Presidents Peter Taylor and Rob Trembath for their continued work behind the scenes to collate all the feedback information and formulate the document outlining the Group Secretaries recommendations so as we can now see what will be needed to move forward in 2026.

This will involve updating the Home Page on our public website, and providing a link to groups outlining Open Days, revamping the Members Register to include more pertinent information, revamping Policies to include clearer definitions and descriptions .

There will be a need for closer liaison between councillors and Group Secretaries which will include a further Forum later in the year.

There has been a suggestion that NSWVGA host an event that will include veteran clubs in the form of a sponsored Open Day. The appropriate access to this will be through the “Grass Roots” process

##### ***Groups and Veteran Clubs***

We now have a situation where we have two Groups with one vets club and one Group with two vets clubs. There is also an imbalance of clubs and distances to be travelled in some cases . This also needs to be looked at with a view of balancing some Groups. This will be discussed at next Wednesdays meeting.

##### ***Sponsorship.***

For some time, there has been nothing done to chase sponsorship for NSWVGA. There was sponsorship from Caravan companies and Golf Equipment outlets, but this has also lapsed. This needs to be revisited by the Executive and a plan devised to look into this.

### ***Value for Your \$5 Membership***

This is one of the most discussed point at the end of last year. It has come to light that there are Veteran clubs that are not registering all veterans rather unless the veteran plays a week of golf nothing is forwarded to NSWVGA for membership. It must be stressed at every opportunity that to participate in any veterans event whether at club, Group or State level you need to be a member of NSWVGA.

We as Councillors have to reinforce the benefits of joining NSWVGA , not for just weeks of golf but the benefits at Club and Group level. Look at the home page of the public website for guidance on this matter.

### ***New Executive Members***

A big welcome to our new members of the Executive, namely Rob Orchard, John Knox and Ashly Bullock. As they ease into their roles as councillors I look to the more senior and experienced councillors to offer support and direction to the newbies. Life Member John Dixon has left the Board and will be missed but he is only a phone call away if anyone needs information or to call on his experience.

### ***Weeks of Golf***

Once again, our Program Co Ordinator Penny Hudson has been hard at work with the nomination packs coming in for this year's program. We have all but one nomination pack on the website at last check. Peter T is looking for a rep at the Matchplay. We have had little response for the Sand Greens Championship week but have had some lukewarm enquiries that both Aileen and I will follow up.

### ***AVGA 2027***

This year will see greater movement towards the presentation of the AVGA Championships in November 2027. Dick Farrant and his committee have this well under control and will report their progress at our February Executive meeting.

### ***Conclusion***

A big year ahead which will have its challenges but that's why we get the big bucks so if we pull together as a team, we will achieve our goals which are:

- 1 To better look after our GS's and vets clubs.
- 2 Provide worthwhile and workable systems that are simple and easy to follow for all.
- 3 Communication both ways.
- 4 Meet new veterans and renew old vets friendships and enjoy Vets golf.

## **Treasurer's Report NSWVGA Executive Council Meeting 4 February 2026**

**Outstanding Action Items** – Contact Richard Farrant to arrange Zoom meeting to arrange receipt of more up to date budget. Follow up was not necessary as Richard Farrant had indicated that a new Budget would be received in January. This one-page extract, in pdf format, was received on 25 January. I have acknowledged receipt and advised that given the extract refers to separate budget sheets I am unable to draw any conclusions in the absence of the separate budget sheets which relate to the Presentation evening at HARS and a separate budget for Trophies during the Championships. I have also acknowledged that I appreciate that at this stage the budgets can only be formative based on estimates in terms of total participants, sponsorships (still to be committed to by any potential sponsors) and associated income and expense items. The only conclusions we can draw at this stage is that the committee is actively pursuing all agreements for course bookings, venue bookings, sponsorships etc as well as attempting to project other Income and Expense lines. Regrettably, I have been unable to locate the Committee's reports in the NSWVGA share drive as I do recall several other key matters have been reported on at the December EC meeting.

**Finance Committee /Grass Roots**- Following Group Secretary forums it is increasing apparent that an urgent review of the structure and quanta of Grass Roots allocations is necessary. Councillors will also have received feedback and observations from several sources including some referred to in the inward correspondence. I will circulate my thoughts on this separately by email as they are only personal views and reflections, I do not believe it is appropriate to include in the meetings as representative of the Council's position which needs to be determined as a matter of urgency and effectively communicated to members.

**Members Register Reconciliation** - As indicated on several occasions last year the Members Register Reconciliation process has been paused for some time pending outstanding Members Register changes, the latest of which is to deal with transition from Golf Link to Golf Australia Connect and the introduction of a Golfld which travels with a golfer for life as she/he moves from club to club. Regrettably, I remain frustrated by a lack of response from my contact at Golf Australia in relation to my request for a club listing prior the retirement of the GolfLink system. This list has been requested by Peter Guy late last year and relayed to Golf Australia. In the absence of any listing though we do still need to be moving on a solution to creating club fields (both home club and Veterans club) as agreed in Teams meeting of 26 November 2025. I have heard on numerous occasions now that we should simply adopt the "old" 5-digit prefix applicable to clubs as a means of allocating club numbers to Members. This club identifier would then still need to be updated manually as members transfer between clubs in the future. The responsibility for the change in this field would seem more suitably allocated to the receiving club for example Gary King currently a member at Inverell for the purposes of this example would have 21708 allocated under a new Home Club and in my simplified example, Veterans Club. If Gary King then moved to Broken Hill, the Group or club Secretary would need to change to Home Club and Veteran Club field to 20730. One problem with this is the potential for change to be overlooked as the member moves. Setting potential pitfalls aside for the moment though if we were to adopt this type of approach to recording Home and Veterans clubs it does have the advantage of only requiring the addition of new Home Club identifiers as new clubs are constructed and commence play. On the other side where clubs unfortunately might cease operation then the transfers would need to be completed by the receiving clubs in terms of my simplified example using Gary King above.

**YOY Financials** – 31 January report is attached, please note significant amount of Journal entries on both Income and Expense. Whilst these entries tend to inflate our turnover results they relate to two significant items. The first simply reflecting the transfer of funds between the Association accounts from the CBA to Bendigo account. For some years now the Association has adopted the practice of using the CBA account for receipt of affiliation fees, sponsorships etc and paying out expenses from the Bendigo account. The main reason for this convoluted approach has been the inability of the CBA online banking platform to cater for the need to have two signatories confirm transactions. The second journal entry in both income and expenses relate to the pass through of a sponsorship of \$3000 from the local council to the Matchplay committee. It was a requirement of the council that the funds be paid to the NSWVGA as an incorporated body. This is apparently a requirement of local government authorities in NSW and has previously occurred at Griffith when the local council provided sponsorship to Griffith committee as sponsorship of Week of Golf. After adjusting for these significant items, overall Income and Expenses YTD are \$39,719.65 and \$23767,81 compared to previous ytd for the same period of Income \$40,584.49 and Expenses of \$21,405.48. The slight comparative increase in Expenses relates to the carry forward of Grass Roots sponsorships awarded in the 2025 FY totalling \$2,250. These sponsorships in turn were for Central West \$750; Paterson Golf Club \$250; Kyogle Golf Club \$250; Woodburn Golf Club \$250; Evans Head Golf Club \$250; Yenda Golf Club \$250 and Leeton Golf Club \$250. Given recent queries regarding value being provided to no travelling members I would commend the committee to strongly publicise these payments in addition to the amount of \$950 recorded in last year's results.

**Other Matters** – Catherine Pautsch has been added to Bendigo Bank as an authorised signatory. This further strengthens any redundancy issue on the Financial Team due to unforeseen illness or similar. After I return from Tasmania in late February, I will begin removing John Dixon as an authorised signatory. Additionally, I will again explore options for CBA ability to meet our dual signatory requirement through online platforms. The hope would be that we could maintain the CBA account as it has more favourable interest rates than the Bendigo account. Finally, after much reflection I have decided to announce my intention not to seek re-election as NSWVGA Treasurer at the end of the year. My reasons for this are several and I will not bore you with each of them.

## **NSWVGA TECHNICAL REPORT – DEC 25**

### ***Email addresses***

Everyone is asked to send all items related to the website – tournament entry documents, news items, tournament results, contact detail changes, etc – to [webmaster@nswvga.com.au](mailto:webmaster@nswvga.com.au) and not to any individual email address. This way these will get to the correct person to handle them.

All queries regarding the Membership Register should be sent to [membreg@nswvga.com.au](mailto:membreg@nswvga.com.au) and not to any individual email address.

Where “SPAM” is shown in the subject of an email, this will have been put in by the recipient's email provider. If you forward or reply to an email that was received with “SPAM” in the subject, edit the subject to remove the “SPAM” before sending it.

The forwarding is also becoming more unreliable, sometimes it works correctly and other times not.

Peter Gron has volunteered to research possible solutions and is liaising with the current supplier.

In the meantime, Catherine is maintaining a master list of email addresses and anyone who wants to send emails to these categories should get the up-to-date list from Catherine each time. Please do not use privately maintained lists.

### ***File sharing – Microsoft OneDrive***

When populating OneDrive, the agreed file naming conventions and procedures should be used. Folders need to be populated with historical data where relevant. When Councillors want to share a file, please place the documents in OneDrive and send an email to Councillors saying where it is. Do not send as an attachment to the email.

New Council Members have been given the required access. If anyone needs assistance, please let me know.

As some internet connections are slow it may take a few minutes for OneDrive to update files so please be aware when using it in the future.

Catherine Pautsch is the main administrator with Peter Guy as backup. If any help is needed, please contact Catherine.

### ***Public website***

Our website will not accept any documents or pictures over 5Mb, and even items this large are difficult to manage. It is not necessary to have high resolution for a website – low to medium resolution is quite adequate. All contributors are asked to try and keep each document or picture to 1Mb or less.

The 2025 program has been removed from the website and the 2027 program added.

Under ‘About Us’ the “Office Bearers” have been updated. This includes History of Executive Council, Group Secretaries and Tournament Directors. Please take time to check these and if any errors have been made, please inform me.

I have approached some Group Secretaries regarding their Vets Days and have put on the website. I will continue to do this.

### ***Membership Register***

Now that the new Golf Australia CONNECT system is rolling out, we see that it identifies the Home Club for each player. A significant improvement is that

when a Golf ID is looked up, it returns not just the GA index but also the name and Home Club of the player. It does not directly identify the gender as previously, but this can be seen from the detail of any of the registered scores.

We need to have access to the official GA table of clubs so that we can replicate it within our Register. This was previously available from a website, but this was taken down in the middle of 2024 - we are chasing this up with Golf Australia.

We have made fixes to the Register to allow the new Golf IDs (8000...) to be entered. However, these temporary fixes do not allow the Home Club to be recognised for these new IDs.

In order to fully implement the new Golf IDs, we have decided to redevelop the functions of the Register and at the same time add new functions. This involves producing specifications, getting quotations and proceeding with development. This will be done in parallel to avoid any disruption to current system operation.

Thank you to these volunteers for supporting NSWVGA in an important role.

Unfortunately, Uralla have decided to withdraw from their 2026 and 2027 Week of Golf Events.

Guyra has moved from October 2026 to the March gap left by Uralla for 2026 and 2027. This event will follow on from the Walcha Championships in 2026.

Moree has come back into the 2026 calendar.

Griffith requested a swap with Leeton Week of Golf in October. Griffith have another important event which would clash. Leeton agreed and this will be a permanent swap which will suit both clubs and travellers moving forward.
